The Commissioners court met in Regular session, February 24th, 1936, with all members present to-wit; Edw. Harper County Judge, T. R. Smith, Commr. Precinct No. 1, E. C. Smith, Commr. Precinct no. 2, P. H. McGown, Commr. Precinct No. 3, R. W. Chapman, Commr. Precinct No. 4, Geo. W. Russell, Sheriff, and Zeda Davidson, Clerk and transacted business as follows:

Accounts were allowed and approved as is shown by Minutes of Accounts allowed;

On motion by T. R. Smith, seconded by R. W. Chapman, with a vote unanimous in favor of said motion, it is ordered by the court that scrip No. 558, issued to W. R. Hyden, in the sum of \$25.00 be cancelled and scrip in lieu thereof be issued out of the same fund, for the same purpose but in sums of \$19.52 and \$5.48.

After considering the written petition of O. P. Williams to be discharged from further duties of Justice of the Peace of Precinct # 3, and the recommendation and application of E. C. Hart, to be appointed as successor Justice of the Peace, of said precinct, and upon motion made by P. H. McGown, seconded by R. W. Chapman, with a vote unanimous for the motion, it is ordered by the court that O. P. Williams' Resignation as said Justice of the peace, be and is hereby accepted, and that the said E. C. Hart is hereby appointed Justice of the Peace for Precinct No. 3, and his bond is hereby approved.

On motion by P. H. McGown, seconded by R. W. Chapman, it is ordered by the court that the following petition be and the same is hereby granted. Petition being as follows, to-wit:

PETITION TO CREATE ELECTION PRECINCT No. 18.

TO THE HONORABLE COMMISSIONER'S COURT:

We, the undersigned resident property taxpaying voters, hereby petition your honorable body to designate the following described sub-division of Sabine County, as Election Precinct No. 18; to-wit: Beginning at a point on the Sabine River, the same being the Northeast corner of the R. E. Harris tract of land; thence in a southwesterly direction with the North western boundary lines of the J. W. Minton and S. M. Bond tracts to the Patroon Creek; Thence down said Patroon creek to the Sabine River; thence up the said Sabine River with its general course to the place of beginning.
