

The Commissioners' court in and for Sabine County Texas met <sup>May 25th, 1936,</sup> in Regular Session, with the following members present to-wit: Edw. Harper, County Judge, T. R. Smith, Commr. Prec. No. 1, E. C. Smith Commr. Prec. No. 2, P. H. McGown, Commr. Prec. No. 3, R. W. Chapman, Commr. Prec. No. 4, Geo. W. Russell, Sheriff, and Zeda Davidson, County Clerk, and transacted business as follows:

Accounts were allowed and approved as is shown by Minutes of accounts allowed;

On motion duly had and carried, it is ordered by the court that scrip in the sum of \$30.00 issued to W. W. Jordan, on the R & B fund, be cancelled, and scrip in lieu thereof be issued for the same purpose, on the same fund but in sums of \$7.50 and 22.50.

At a meeting of the Commissioners Court of Sabine County, Texas, among other business came on to be considered the settlement of the property damage claim growing out of a collision between a 1936 Chevrolet truck owned by J. C. Harvey, motion Number 5748498 and license numbered 172-248, and a 1935 Ford V-8 Truck, license X8-146 belonging to Precinct # 1, Sabine County, Texas, and/or Sabine County, and it being made known to the Court that J. C. Harvey had offered in settlement of the damages done to the aforementioned Ford V-8 Truck the sum of \$36.25 as full and final payment for all damages of every kind and character to the property of said Precinct and/or County, growing out of or resulting from said collision, which collision occurred on or about April 6, 1936, and which settlement the Court feels to be just and fair. And the County Judge and Commissioners are authorized to execute a release for said damages and all claims upon payment of said sum of money.

Motion was made by P.H. McGown, and seconded by R. W. Chapman, and unanimously passed at said Commissioners court and accepted said sum of \$36.25 in full and final payment of all damages aforesaid done at a meeting of Commissioners court at Sabine County, Texas, this the 25 day of May, A. D. 1936, with the following persons present at said meeting; Edw. Harper, County Judge, Sabine Co., Texas, T. R. Smith, Commissioner, Precinct # 1, P. H. McGown, Commissioner,

Precinct # 3, R. W. Chapman, Commissioner, Precinct # 4.

There being no further business, court adjourned, and in the same day convened as a Board of Equalization, and after having taken the oath of office, adjourned to meet for such purposes on the 28th day of May, 1936.
