TO THE HONORABLE COMMISSIONER'S COURT

AND

BOARD OF EQUALIZATION OF SABINE COUNTY
TEXAS

Pickering Lumber Company and T.M. Barham and Clifford Histed, Trustees of the property and assets of Pickering Lumber Company, come now and protest the value placed by your Commissioners Court sitting as a Board of Equalization on the 15th day of July 1937 on the properties embraced in its rendition for the year 1937, for the following reasons:

- (1) Said valuation are excessive;
- (2) Said valuation are out of proportion to the valuation by you upon property in general in Sabine County, Texas.
- (3) His said properties were arbitrarily valued by the Court sitting as a Board of Equalization without regard to their character or classification, and in utter disregard of the testimony offered by the owner; that said valuation were arbitrarily made without the introduction on behalf of said Board of any evidence or testimony to support the action of the said Board.
- (4) Said valuation on cut-over lands are in excess of the true market or intrinsic value of said lands and confiscatory in their nature.

Wherefore, said Company gives notice of its protest and of its intention to invoke the said of the constitution and statutes of the State of Texas; guaranteeing that taxation shall be equal and uniform.
