WHEREAS, it has come to the attention of the Commissioners' Court of Sabine County, Texas, in regular session on this, the 14 day of Feb. 1938, that the State Highway Commission has, by its Minute No. 12861, dated September 22, 1936, ordered that all landscape development projects in the future will be confined to those highways or portions thereof, where the County, in which the project is located, agrees to secure for and on behalf of and without cost to the State, agreements from all property owners whose land lies between the limits of such

projects and within a distance of three hundred (300) feet of the highway, measured perpendicularly from rights-of-way or boundary lines of such landscape projects, whereby each property owner agrees not to erect or permit the erection of signs of any and all kinds and agrees to remove or cause to be removed all signs of any and all kinds within this area.

It is therefore ordered that Sabine County, acting herein by and through its Commissioners' Court, agrees and obligates itself to secure agreements, based on good and sufficient considerations, from all property owners whose land lies between the limits of Project No. \_\_\_\_\_ on Highway No. 8, from County Line at Brookeland to Bronson Highway 184 from Hemphill to Bronson and Highway to 21 from Pendleton Ferry Bridge to the San Augustine County Line, not to erect or permit the erection of signs of any and all kinds, and to remove or cause to be removed all signs of any and all kinds, within a distance of three hundred (300) feet of the highway, measured perpendicularly from rights-of-way or boundary lines of the landscape project.

It is ordered by the Court that the bonds executed by National Surety Corporation for \$1000 and 3,000 covering Andrew Lawrence Harvill as Road Supt. and as County Commissioner be cancelled and the above named Surety be relieved and they hereby are relieved of any and all liability in connection therewith. This release of liability to date from Jan. 1, 1938. It is further ordered by the Court that the above named Surety be also relieved of liability by cancellation of the <sup>two</sup> bonds they executed Jan. 1, 1938, covering Robert Henry Solly as Road Supt and County Commissioner. This release of liability and cancellation to date also from Jan. 1, 1938.

This action is taken because the above named officers have filed, and the Court has approved, new Bonds with a different Surety.

On this date there came on to be heard the petition for a local option election in Justice Precincts 1,2,3, and Commissioner's Beat # 1, signed by A. L. Walker, and 126 other citizens of Sabine County. It is the order of the Court that the petition be, and hereby is referred to the County Attorney to be checked for legal sufficiency and report to the court. The County Attorney is requested, if there be any matter that is confusing, to refer said matter to Attorney General for a ruling.

This being all the business, Court adjourned.
