AGREEMENT BY MUNICIPALITY OR POLITICAL
SUBDIVISION TO MAINTAIN HIGHWAYS IMPROVED
UNDER PROVISIONS OF FEDERAL HIGHWAY ACT
AS AMENDED AND SUPPLEMENTED

The County of Sabine, State of Texas, hereinafter referred to as County, and the Texas Highway Department, hereinafter referred to as the Highway Department, hereby agree as follows:

1. That the Highway Department will submit a project for the improvement of 3.354 miles of the Feeder highway from Int. with U. S. Hwy 59 to Magasco, known as Pineland-Magasco Spur, and to be designated as Texas FAS project No. 90-A, and will recommend its approval by the Secretary of Agriculture for construction, with funds apportioned to the State under the Federal Highway Act as amended and supplemented; subject however, to the condition that the County shall provide for its proper maintenance after completion of its improvement.

2. That the said County hereby requests the Highway Department to submit the aforementioned project with recommendation that it be approved by the Secretary of Agriculture, and agrees that if such project is approved and constructed by the Highway Department and the Secretary of Agriculture it thereafter, at its own cost and expense, will maintain the project in a manner satisfactory to them, or their authorized representatives, and will make ample provision each year for such maintenance.
