MEMORANDUM OF AGREEMENT FOR RELEASE OF TERRITORY FROM
FEDERAL AND STATE QUARANTINE

The County Commissioners of Sabine County, State of Texas, have inspectors of the Livestock Sanitary Commission, appointed to examine cattle of this county for the purpose of detecting the presence of ticks which transmit southern cattle fever, and to enforce the necessary disinfection of animals and premises under the rules and regulations of the State Livestock Sanitary Commission and the laws of Texas, in cooperation with the representatives of the Bureau of Animal Industry of the United States Department of Agriculture.

All cattle and premises known to be infected with or exposed to fever ticks have been quarantined according to law, and will be kept in quarantine until released by written order issued by the Chairman of the Livestock Sanitary Commission of Texas.

WE HEREBY AGREE to lend our assistance to prevent the illegal admission into this County of any cattle or horse stock from adjoining counties and states within the quarantined area, and support by law enforcement all reasonable means looking to the control and eradication of splenic fever infection now known or which may hereafter be found.

IN VIEW OF THE ABOVE, and because of the further fact that the United States Department of Agriculture will release that part of Sabine County, described as follows: entire county, from Federal quarantine if the action requested in this petition be taken by the Livestock Sanitary Commission of Texas, we, the said County Commissioners' Court, do petition the Livestock Sanitary Commission of Texas to cause the said Sabine County, Texas, (or portion of county fully described) to be released from quarantine in order that uninfected and unexposed cattle may be moved without further restrictions. We the said County Commissioners further agree to cooperate with the Livestock Sanitary Commission of Texas in maintaining control of cattle and the enforcement of quarantine laws and regulations in the above mentioned territory herein recommended for release from quarantine.
