Accounts were allowed as shown in "Accounts Allowed".

It is the order of the Commissioner's Court that the monies in Lateral Road Fund to credit of Sabine County in possession of State Board of County & District Road Indebtedness be transferred to Sabine County for use of the several commissioners Precinct's for Lateral road construction.

The Treasurer is authorized to borrow from Rd. Dis. 10 Construction Funds, not to exceed \$400.00 to supplement available funds to make the Oct. 10 payment on Coupons due on Road Dist. 10 Bonds, 1939 issue.

It is ordered by the Commissioner's Court that H. B. Arnold be employed for the purpose of checking the records and ascertaining additional mineral interests owned in this county and not being rendered for taxes, as well as timber only owned and not being rendered; and also that a check be made of the Assessor's and other records to eliminate double renditions and other valuations of property that do not exist. And that the said H. B. Arnold be paid the sum of \$250.00 as compensation for said service.

Commissioner's Court re-convened on Saturday, October 19, 1940, and the following petition

for an Election UPON THE QUESTION OF AUTHORIZING THE COUNTY TO TAKE OVER THE ROADS AND COMPENSATE ROAD DISTRICTS AND AUTHORIZE ADDITIONAL ROAD BONDS, was presented to the Court.

THE STATE OF TEXAS:

COUNTY OF SABINE :

TO THE HONORABLE COMMISSIONERS' COURT OF SABINE COUNTY, TEXAS: We, the undersigned resident property tax paying voters of Sabine County, Texas, respectfully pray your Honorable Court to order an election to be held in said County to determine whether bonds of said County shall be issued for the following purpose:

The issuance of County Bonds for the purchase of District roads and the further construction, maintenance and operation of macadamized, graveled or paved roads and turnpikes, or in aid thereof, throughout Sabine County, as follows:

FIRST: Bonds to be issued in the aggregate sum of \$244,000.00 for the purchase of Road District roads in said County, which Bonds shall be issued in similar denomination, bearing the same rate of interest, having the same date of maturity, and with similar options of payment as the outstanding district bonds as heretofore issued and are now outstanding against Road Districts Numbers 1, 2, 3, 4, 5, 6, 7, 9, 10, 12 and 13 of said County.

SECOND: Bonds to be issued in the aggregate sum of \$2,000.00 for the further construction, maintenance and operation of macadamized, graveled or paved roads and turnpikes, or in aid thereof, throughout such County, which Bonds may run for a term not to exceed forty years from their date, as may be determined by the Commissioners' Court of said County and shall bear interest at the rate of 5% per annum:

We further pray your Honorable Court that at such election there shall also be submitted to the qualified electors who own taxable property in said County and who have duly rendered same for taxation, the question of whether or not an Ad-Valorem tax shall be levied on all taxable property within said County for the purpose of paying the interest on said bonds and to provide a sinking fund for the redemption thereof.
