 being present, with the following absent, to-wit: A. L. Harvill, constituting a quorum, at which time the following proceedings were had:

The Judge presented for consideration the petition of E. J. #cGown, and 311 other persons praying that an election be ordered in said County on the question of the issuence of Road bonds.

Commissioner Speights introduced a proposed order and made a motion that it be passed.
The motion was seconded by Commissioner Carter. The order was read in full by the Clerk.

The motion was carried by the following vote:

AYES: Commissioners peights, Ener, and Carter.

'NOES: None.

The order as passed is as follows:

AN ORDER ...

CALLING ROAD BOND ELECTION

WHEREAS, a petition has been filed with the Court, signed by E. J. McGown and 311 other persons, praying that an election be ordered on the question as to whether or not the bonds of said County shall be issued in the amount of \$246,000.00, for the purpose of the purchase of Road Pistrict roads in said County, and the further construction, maintenance and operation of macadamized, graveled or paved roads and turnpikes, or in aid thereof, throughout such County, and whether or not an ad valorem tax shall be levied on all taxable property within said County for the purpose of paying the interest on said bonds and to provide a sinking fund for t redemption thereof; and

WHEREAS, it appears to the Court, and the Court officially finds that said petition is signed by 312 persons, who are resident, qualified electors of said County owning taxable proper in said County, and who have duly rendered same for taxation; and

WHEREAS, it appears to the Court that the amount of bonds to be issued will not exceed one-fourth of the assessed valuation of real property of said Debine County; and

Whereas, it appears to the Court that the certain Road Districts in Sabine County, Texas, have neretofore issued hoad Bonds under the provisions of Article III, Section 16 of the Constitution of the State of Texas, and Statutes enacted pursuant thereto;

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONERS' COURT OF SABINE COUNTY, TEXAS:

That an election shall be held in said County on the 23 day of November, 1940, which is not less than thirty days from the date of this order, at which election the following proposition shall be submitted;

"Whether or not the bonds of said County shall be issued in the amount of \$246,000.00 for the purpose of the purchase of district roads, and the further construction, maintenance and operation of macadamized, graveled or paved roads and turnpikes, or in aid thereof, throughout Sabine County as follows.

FIRST: Bonds to be issued in the aggregate sum of \$244,000.00, for the purchase of districts roads in said County, which bonds shall be issued in similar denomination; bearing the same rate of interest, having the same date of maturity, and with similar options of payment as the outstanding district bonds as heretofore issued and are now outstanding against Road Districts Numbers 1, 2, 3, 4, 5, 6, 7, 9,10,12 and 13 of said ounty;

SECOND: Eonds to be issued in the aggregate sum of *2,000.00, for the further construction, maintenance and operation of macademized, graveled or paved roads and turnpikes ordin aid thereof, throughout such County, which bonds may run for a term not to exceed forty years from their date, as may be determined by the Commissioners' Court of said County and shall bear interest at the rate of 5% per annum.

And whether or not an ad valorem tax shall be levied annually on all taxable property in said county sufficient to pay the annual interest and provide a sinking fund sufficient to pay said bonds at maturity."

The said election shall be held under the provisions of Chapter 3, Title 22 of the Revised Civil Statutes of Texas, 1925, as amended, including the provisions of Chapter 16, Acts of the First Called Session of the Thirty-Ninth Legislature.

All persons who are slegally qualified electors of this state and of this County, who own taxable property in the County, and who have duly rendered the same for taxation, shall be qualified to vote, and all such electors shall vote in the election precinct of their residence and all voters desiring to support the proposition to issue the bonds shall have written or printed on their ballots the words:

"FOR THE ISSUANCE OF BONDS AND THE LEVYING OF THE TAX IN PAYMENT THEREOF."
And those opposed shall have written or printed on their ballots the words:

"AGAINST THE ISSUANCE OF BONDS AND THE LEVYING OF THE TAX IN PAYMENT THEREOF."
