Accounts were allowed as shown in Minutes of "Accounts Allowed".

It is ordered by the Court that \$100.00 from Road District #7, be paid to A.L! Coleman on bonds No. 12 and No. 13, which are in judgment form.

It is ordered by the Court that \$165,00 past due interest on Bond No. 2 of Road District No. 13, be paid to First National Bank, San Augustine, in exchange of General County Bu Script

It is ordered by the Court that the County Treasurer pay \$22.00 out of Road District #7, as all past due interest and up to March 1st 1941, on Bond No. 14; of Road District #7.

At this regular meeting of the Commissioners! Court on this 24-day of Feb. 1941, the question of an investment for surplus funds of Road District #10, came up for discussion. After consideration and discussion, it was moved by Com. Drayton Speights and seconded by Com. G.B. Carter and unanimously carried, that \$2000.00 of surplus funds on deposit with State for Road District #10, he invested in \$2000.00, Sabine County Road District #1 bonds, Nos. 39, and 40, bearing 5% interest and maturing Aug. 15, 1952, at par, and the Board of County &

District Road Indebtedness and/or the State Treasurer are hereby requested to make payment for these bonds when presented to them by the First National Bank, San Augustine, and to hold said bonds for the benefit of said Road District #10.

It is further ordered that the County Judge and County Treasurer be directed to take whatever steps necessary to carry out this order.

There came on to be considered the motion of Commissioner G.B. Carter, seconded by Commissioner, Lee Arnold, for the adoption by the Commissioners! Court of the following order for the issuance of a refunding band of SABINE COUNTY, TEXAS ROAD DISTRICT NO.7, and for the levy of a tax sufficient to pay the interest thereon and discharge and redeem said bond at maturity, and which order is as follows:

WHEREAS, by an order duly passed by the Commissioners' Court of Sabine County, Texas, on the 12th day of March, 1923, ROAD DISTRICT NO. 7 of SABINE COUNTY, TEXAS, was duly and legally authorized and empowered to issue its FIVE AND ONE-HALF PER CENTUM (5½%) Road Bonds, in the aggregate amount of TEN THOUSAND DOLLARS (\$10,000.00), all dated on the 1st day of March 1923, numbered from one (1) to twenty (20), inclusive, in denomination of FIVE HUNDRED DOLLARS (\$500.00) each, payable serially, and of which issue of bonds there is outstanding and unpaid an indebtedness against said Road District for the sum of FIVE HUNDRED DOLLARS (\$500.00), evidenced by said Bond Number 14 due March 1, 1937;

AND WHEREAS, the Commissioners' Court of said County considers it advisable and to the interest of said ROAD DISTRICT NO. 7, to refund this FIVE HUNDRED COLLAR (\$500.00) BOND of the said series of TEN THOUSAND DOLLARS (\$10,000.00), by issuing and delivering to the proper holder of the said FIVE HUNDRED DOLLAR (\$500.00) BOND, the refunding bond of said ROAD DISTRICT No. 7, bearing interest at the rate of FIVE AND ONE-HALF PER CENTUM (5%), and due and payable February 1, 1943; therefore,

BE IT ORDERED BY THE COMMISSIONERS! COURT OF SABINE COUNTY, TEXAS:

That under and by virtue of the Constitution and Laws of the State of Texas, especially Section 52, of Article 3, of the Constitution, and Chapter 74, of the General Daws Passed by the Forty-first Legislature, at its Second Called Session in 1929, the bond of Road District Number 7, of Sabine County, Texas, in the aggregate sum of FIVE HUNDRED DOLLARS (\$500.00), be issued in the name of said District, for the purpose of refunding an equal amount of bond outstanding against said District.

That such Refunding Bond is to be known as "SABINE COUNTY, TEXAS, ROAD DISTRICT NUMBER 7 REFUNDING BOND, SERIES A of 1941"; to be issued in the sum of FIVE HUNDRED DOLLARS (\$500.00); to be numbered one (1); in the denomination of FIVE HUNDRED DOLLARS (\$500.00); to be dated February 1, 1941 and to mature and become due and payable February 1, 1943.

That said bond shall bear interest at the rate of FIVE AND ONE-HALF PER CENTUM (52%); Such interest to be evidenced by proper coupons attached to said bond; and said interest shall be payable on August; 1, 1941 and semi-annually thereafter on FEBRUARY 1st and AUGUST 1st in each year.

Any surplus in the Sinking Fund Account of the bond hereby refunded shall be passed to the credit of the Sinking Fund Account of said Refunding Bond, and any and all taxes uncollected from levies heretofore made on account of the bonds which are being refunded by this issue, shall when and as the same are collected, be credited to the Sinking Fund Account of this Refunding Bond; provided, however, that such transfer of the Sinking Fund Account and pledge of uncollected taxes is made only so far as may lawfully be done consistent with the rights of the holders of the outstanding bond.
