That the State Board of County and District Road Indebtedness, at Austin, Texas, be, and it is hereby authorized and directed to remove the above described "ROAD BONDS OF ROAD DISTRICT NO. 4, OF SABINE COUNTY, TEXAS", numbers 69 and 70, from its record of outstanding indebtedness of said District, inasmuch as said bonds were never issued and sold and are not outstanding.

The above order having been read, the County Judge put the motion of Commissioner D. B. Speights to a vote, and such motion carried by the following vote: Commissioners D. B. Speights, G. B. Carter, J. T. Ener, T. L. Arnold voting "AYE", and none voting "NO".
