The Honorable Commissioners' Court met in regular session at its regular meeting place in Hemphill, Texas, on July 28th 1941, with the following members present, to-wit:

It is hereby ordered by the Court that 2-1/5 acres on Albert Brister Survey now rendered to A.L.Harper be valued at \$30.00 for the years 1930 to 1940 inclusive, for County taxes.

"WHEREAS, Common School District No.14, of Sabine County, Texas, has heretofore legally issued its bonds known as "COMMON SCHOOL DISTRICT NO. 14 SCHOOLHOUSE BONDS," dated May 16, 1921, Nos. 1 to 10, inclusive, in the denomination of \$150.00 each, aggregating \$1,500.00, bearing 6% interest per annum, due and payable twenty (20) years from their date and optional at any time after ten (10) years from their date; and,

WHEREAS, of the above described issue there is now outstanding and unpaid an indebtedness against said District in the amount of \$1,000.00 which may be refunded at this time; and

WHEREAS, the Commissioners Court of Sabine County deems it advisable and to the best interest of said Common School District No.14 that said \$1,000.00 of outstanding bonds be refunded; now,

THEREFORE BE IT ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONERS' COURT OF SABINE COUNTY, TEXAS:

Section 1. That the bonds of Sabine County Common School District No.14 to be called "COMMON SCHOOL DISTRICT NO. 14 REFUNDING BONDS," be issued under and by virtue of the Constitution and Laws of the State of Texas to the amount of One Thousand (\$1,000.00) Dollars, for the purpose of refunding, cancelling and in lieu of a like amount of valid and outstanding indebtedness of Common School District No.14 evidenced by Schoolhouse Bonds of said District dated May 16, 1921.

Section 2. That said bonds shall be numbered consecutively from 1 to 20, inclusive, and shall be of the denomination of \$50.00 each, aggregating \$1,000.00.

Section 3. That said bands shall be dated May 16, 1941, and shall become due and payable serially as follows: \$50.00 on May 16th of each of the years 1942 to 1961, inclusive.

Section 4. That said bonds shall bear interest from date at the rate of Three and three-fourths (3-3/4%) per cent per annum, payable May 16, 1942 and annually thereafter on May 16th of each year, which interest shall be evidenced by coupons attached to each of said bonds.

Section 5. That the principal of and interest on said bonds shall be payable in lawful money of the United States of America upon presentation and surrender of bond or proper coupons at the Office of the State Treasurer in Austin, Texas.

Section 6. That each of said bonds shall be signed by the County Judge, countersigned by the County Clerk and registered by the County Treasurer of Sabine County, Texas, and the seal of the Commissioners Court shall be impressed upon each of them.

Section 7. That the facsimile signatures of the County Judge and the County Clerk may be printed or engraved upon the coupons attached to said bonds and shall have the same effect as if they had been signed by them.

Section 8. That the form of said bonds shall be substantially as follows: \$50.00

Section 11. It is further ordered by the Commissioners Court of Sabine County,
Texas, that to pay the interest on said bonds and create a sinking fund sufficient to discharge
them at maturity, a sufficient tax on each \$100 valuation of all taxable property in Common
School District No. 14 of Sabine County shall be annually levied on said property and annually
assessed and collected until said bonds and interest thereon are paid, and said tax is hereby
levied for the year 1941 and for each succeeding year while said bonds are outstanding, a tax
for each year at a rate from year to year, as will be ample and sufficient to provide funds to
pay the current interest on said bonds and to provide the necessary sinking fund, shall be and
is hereby levied for each year, respectively, while said bonds, or any of them, are outstanding
and unpaid, and said tax shall each year be assessed and collected and applied to the payment
of the interest on and principal of said bonds.

Section 12. All moneys in the sinking fund of the issue of bonds hereby refunded, and all taxes in process of collection for the issue of bonds hereby refunded, are hereby appropriated to the sinking fund of this issue of refunding bonds.

Section 13. It is further ordered that the County Judge of Sabine County shall be authorized to take and have charge of all necessary records pending investigation by the Attorney General and shall take and have charge and control of the bonds herein authorized pending the approval by the Attorney General. After the record and the bonds have been approved by the Attorney General, the bonds shall be left in the care and custody of the Comptroller of the State of Texas, and the State Comptroller is hereby authorized to accept from the holders thereof the obligations hereby refunded, and after cancellation thereof, register a like amount of the bonds herein authorized and deliver same to the State Treasurer for the benefit of the State Permanent School Fund.

The above order being read, it was moved and seconded that same do pass. Thereupon, the question being called for, the following members of the Court voted AYE: D.B.Speights, J.T. Ener, G.B.Carter, T.L.Arnold; and the following voted NO: NONE.
