terest coupon. The Escrow Agent is further authorized to deduct from sums received from the County Treasurer and remitted to Crummer & Company and M.L.Daniels 2% as fees for services rendered hereunder as Escrow Agent.

3. The County Treasurer of Sabine County is authorized, instructed and directed to pay over to the First National Bank of SanAugustine, Texas, as Escrow Agent, from time to time all sums of money received by him from the County Tax Collector representing the collection of taxes belonging to the interest and sinking fund of the outstanding Road Bonds of the respective Road Districts Numbers 1, 4, 5, 6 and 12, until he shall have paid to said Escrow Agent an amount equal to 50% of the total face value of the obligations enumerated in Section 1 above; provided, however, that the County Treasurer shall first reserve out of each year's tax collections received by him for each Road District, a sum of money sufficient to pay the annual interest due in that year on the Refunding Bonds dated April 1, 1941, of said respective Road Districts, in accordance with the provisions of the refunding agreement between the Commissioners' Court and M.L. Daniels dated April 28, 1941, and the refunding bond orders heretofore adopted pursuant thereto by the Commissioners' Court on the 17th day of May, 1941, with respect to each of said enumerated Road Districts, and the further orders of the United States District Court for the Eastern District of Texas, in Cause No.558 in Equity, with respect to Road District No. 1, and cause No. 559, in Equity with respect to Road District No.4.

4. If the County Treasurer and/or other County officers of Sabine County, Texas, shall not have paid said Escrow Agent the full emount due hereunder within five years from date hereof, the Escrow Agent shall deliver all unpaid interest coupons and certificates of Indebtedness to Crummer & Company, Inc. of Texas, and M.L.Daniels, of Dallas, Texas, or to whomsoever they may in writing direct. In the event the Escrow Agent shall have paid to Crummer & Company, Inc., of Texas, and M.L.Daniels, all amounts due in liquidation of the securities herewith deposited, or in the event said securities shall not have been paid within five years from the date hereof, and the unpaid securities shall have been returned as hereinabove provided, said Escrow Agent shall thereupon become discharged from any further duties, obligations or liabilities under this agreement.

5. The Escrow Agent shall not be liable for any act or omission on its part or any of its agents or employees, nor for any error of judgment or mistake of law in performing its functions as herein specified, but shall be liable to any party injured by its gross or wilful negligence in that connection.
