We, the undersigned persons, constituting a majority of the owners of the hereinafter described lands, which adjoin lands over which a stock law now prevails, and in which hogs, sheep and goats are not permitted to to run at large, hereby petition your honorable body to include in said existing stock law territory the following described territory in which there are less than twenty (20) freeholders, and that you pass an order extending the stock law forbidding the running at large of hogs, sheep and goats to include the hereinafter described lands, said lands requested to be included in said stock law being described by metes and bounds as follows:

BEGINNING at a point on the South Bank of Housen Bayou where the divisional line of the Sion Smith League crosses said Bayou at the N.E. corner of 70 acres, more or less of said survey owned by P.S.Goen, and the N.W.corner of 28 acres owned by W.I. Davis;
