Upon Motion by H. J. Hamilton, Seconded by B. E. Marshburn, it is ordered by the Court that the following Hog Law Petition be granted:

TO THE HONORABLE COMMISSIONER'S COURT OF SABINE COUNTY, TEXAS

I, J. E. Finley, the owner of the hereinafter described land, which adjoins lands in which a hog law now prevails and in which hogs, sheep and goats are not permitted to run at large, hereby petition your honorable body to include the following lands and territory in said stock law territory, and that you pass an order extending the stock law territory, and that you pass an order extending the stock law forbidding the running at large of hogs, sheep and goats in such territory, which territory is described as follows:

Beginning at a point on Tebo creek at the S. E. corner of what is known as the E. J. McGown 125 acres, more or less; Thence North with the East line of said McGown tract to the S. W. corner of a tract of 58 acres owned by J. H. Conn; Thence East with Conn's South line to corner in the West line of 70 acres owned by J. H. Conn, being the North East corner of J. E. Finley's land; Thence South with Conn's west line and Finley's East line to the Tebo Creek; Thence up said creek to the place of beginning, containing 58½ acres, more or less.

It is ordered, adjudged and decreed that the following described road and Bridge Bonds, Series 1931, now belonging to various funds be traded to County Wide Fund as set out below, and the County Treasurer and/or County Judge authorized and directed to carry out this order; That Road District #2, trade \$2,000.00 Road and Bridge, Series 1931, #6-50 to County Wide for \$2,000.00 General Funding, 9-1-26, #40/41; That Road District #10 trade \$6,000.00 Road & Bridge, Series 1931, #12/13-44-47-54/55 to County Wide for \$6,000.00 General Funding 9-1-26, #42/45-53/54; That Road District #10 trade \$2,000.00 Road & Bridge Funding 5-15-28, #26/27 to County Wide for \$2,000.00 General Funding, 9-1-26, #57/58.

IT APPEARING that the Permanent School Fund of Sabine County, Texas, now owns \$2,000 Sabine County, Texas, Road and Bridge Funding Bonds, Series 1931, Nos. 71 and 72, and that said bonds should be traded to the County for other bonds now owned by the County;

THEREFORE IT IS ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONER'S COURT OF SABINE COUNTY, TEXAS, that the herein above described bonds be traded by the Permanent School Fund to the Sabine County Wide Fund for
