Tax Levy of 2¢ out of 25¢ General Fund

On this 13 day of Jamuary 1947 being a regular meeting of the Commissioners Court with all members present to-witt; Chas. Forse, Co. Judge; Gram Conn, Comm. Prec. #1; E.C. Smith, Comm. Prec. #2; J.R. Thomas, Comm. Prec. #3; Hollis Vickers, Comm. Prec. #4. The following order was passed.

That the above named members of the Copm. Ct. together with G.E.Morris as County Treasurer of Sabine County and Claude Vickers, as Tax Collector & Assessor of said county set aside the proceeds from 1 cent of the 25¢ General Fund Levy for the Fiscal year of 1946 &1947 collected from and after Oct. 1, 1946 and a like proportionate amount of all Del Taxes collected for said period of time, into a special fund to denominated Sabine County, Texas Gen. Fund, Judgement Fund No. 1 and on March 1, 1947, and thereafter at reasonable intervals as funds accumulate into said fund, pay the balance to the creidit of said Fund to Justie: H. Fugate Attorney of record for the above named plaintiffs and this levy shall be made in each of two Judgements pemding in Fed. District Court Emt. Division & numbered on the docket of said Court towitt Civil Action 363, and equity 544, thereby totaling 2¢ of the 25¢ Gen. Fund Levy.

That for each succeeding fiscal year the defendants above named shall levy a tax at the rate of one cent (1¢) on each \$100.00 of taxable property in Sabine County out of the twenty-five (25¢) tax abailable for General Fund purposes and pay the proceeds into said Sabine County, Texas General Fund, Judgement Fund No. 1, and pay same to Justus H. Fugate, Attorney for the Plaintiffs, on March 1 of such successive years with like credits to be given forthwith upon said judgement by the plaintiffs through their said Attorney.

That said levy in such amount shall continue to be made by said defendants above named, and their s successors in office for succeeding years, until the further order of this Court pursuant to motions filed herein by either of the parties to this cause.
