

The Honorable Commissioner's Court met in regular session in the regular meeting place on Monday, May 26, 1947, with the following members present to-wit: Chas. Forse, County Judge, G. B. Conn, Commissioner Precinct No. 1; E. G. Smith, Commissioner Precinct No. 2; J. R. Thomas, Commissioner Precinct 3; H. J. Vickers, Commissioner Precinct No. 4.

On motion of J. R. Thomas and seconded by G. B. Conn it was ordered by the Court that warrant # 16955 in the amount of \$2312.92 issued to Boehick Engineering Co. Inc. be issued with the understanding that it not be registered with the County Treasurer until April 5, 1948 and then payable by Commissioners Precinct Number 3.

In consideration of the First National Bank of San Augustine, Texas, temporarily delaying the collection of \$11346.26 Sabine County Road and Bridge scrip of Precincts Nos. 1, 2, 3 and 4, which said bank has taken up for Sabine County, Sabine County through its Commissioners' Court hereby agrees as follows:

The Commissioners' Court of Sabine County hereby irrevocably agrees that this scrip will be purchased by Sabine County from any surplus funds in the county, and all of the surplus funds coming into Sabine County-wide fund and Sabine County Road District #10 fund from this year's levy are hereby pledged for the purpose of taking up this scrip for investment of said fund, just as soon and as quickly as said surplus funds become available. The County Treasurer is hereby ordered and directed to make payment for said scrip as investment for said county-wide fund and Road District #10 fund as funds become available.

The above order having been read it was moved by Commissioner E. C. Smith and seconded by Commissioner H. J. Vickers that said order be passed and agreement made and upon the question being called, with Commissioners Conn, Smith, Thomas and Vickers voting AYE and no one voting NO, it was unanimously passed.
