PURSUANT TO AN ORDER issued by the Commissioners' Court of Sabine County, Texas, dated the 11th day of Oct. A.D. 1948.

NOTICE

is hereby given that an Election will be held on the 24 day of Nov. A.D. 1948, in Election Precinct no. 3, at Brookeland, for the purpose of determining whether hogs, sheep and goats shall be permitted to run at large within the hereinafter described territorial limits, viz:

Beginning at the point where the Sabine and Jasper County line crosses the south line of the Donald McDonald League; thence N 75 W to the point where the south line of said McDonald League crosses the Sabine and San Augustine county line; thence North west with said county line to the point where said county line crosses the west line of the Donald McDonald League; thence N 15 E with the west line of said McDonald league to the Northwest corner of said league; thence S 75 E with the north line of said McDonald League to the Bear Creek; thence up Bear Creek with its meanders to the mouth of Devil's Ford Creek; thence up Devil's Ford Creek with its meanders to the point where said creek crossed the North or Northeast line of the Samuel Nelson Survey; thence S 49 E with the north or northeast line of the Nelson Survey and the north or northeast line of the M. Cummings League to the N.E. corner of said Cummings League on the McKim south league line; Thence S 52 West with the Cummings East line to the Sabine and Jasper County line; thence westerly, about S 79 W with said County line to the place of beginning.

(a) The voting place shall be Brookeland, Texas; and D. E. Willis is named Manager and they shall select necessary assistants. (b) And voting shall be at the regular voting places within the above designated area, and the officers of election heretofore appointed by the Commissioners' Court on the 11 day of Oct. A.D. 1948, and qualified under the laws of this State to hold elections at the respective voting places in said Sabine County, Texas, be and they are hereby directed to hold this election.

Vote at said election shall be by ballot which shall have written or printed thereon the following:
