The returns of the Election held on the 18th day of August, A.D.1951, at Sexton, in precinct No. 5, Sabine County, Texas, for the purpose of determining whether hogs, sheep and goats shall be permitted to run at large within the territorial limits of Sexton community, were canvassed with the following results found:

ORDER DECLARING RESULT OF

STOCK LAW ELECTION

THE STATE OF TEXAS

IN THE COMMISSIONERS' COURT OF

COUNTY OF SABINE

SABINE COUNTY:

On this the 27th day of August, A.D. 1951, came on to be considered the returns of an election held on the 18 day of August, A.D. 1951, in Election Precinct No. 5, of this County, upon the question of determining whether hogs, sheep and goats shall ber permitted to run at large in certain territorial limits, more particularly described as follows:

Beginnning at the point where the County line between Sabine and Shelby County intersects Martinez Bayour on the Jos. W. Brightman Survey; thence in a Southwesterly direction with and following the County line between Sabine and Shelby County to the N.W. comer of Sabine County at the point on the W.S. Smith, survey, where the Sabine and Shelby County line, the Shalby County and San Augustine County line and the San Augustine County and Sabine County line all coverage; Thence South with the Sabine and San Augustine County line to the North line of the E.A.Lloyd Survey; thence east with said Lloyd N.line to the N.E. corner of said Lloyd Survey; Thence South with Lloyd's E. line to the S.W. corner of the Francis Richards Survey on the N. line of the David Renfro League; Thence N. 85 E. with the N.line of said David Renfro League to its N.E. corner; Thence South 5 W. with the East line of said Renfro League to the N.W. corner of the J.D. Jones survey; thence S. 88 E. with the N. line of said Jones survey and the South line of the Jose'Alameda survey to the extreme Southeast corner of said Alameda Survey, being one of the corners of the S.P. Tatom survey; thence N. 24 E. with Alameda E. line to the extreme East corner of said Alameda Survey on the South line of the John McAdams Survey; Thence South 65 East with McAdams South line to its S.E. corner on the West line of the Wm. Defee Survey, abstract 86; thence N. 25 E. with the West line of said Defee Survey and the W. line of Richard Slaughter League to the N.W. corner of said Richard Slgughter League; Thence South 65 E. with Slaughter's N. line to the Southwest corner of the W.B.Frazier survey; thence N.25 E. with the west line of said W.B.Frazier survey and the west line of the Philip Smith Survey to the Martinez Bayou; Thence up said Martinez Bayou with its meanders to the place of beginning.

And it appearing that said election was in all respects legally held and that said returns were duly and legally made and that there were cast at said election 28 votes, of which number three were cast:

FOR THE SWOCK LAW 15 Votes AGAINST THE STOCK LAW 13 Votes

And it appearing to the Court from said returns that a majority of the legally qualified voters of said District, voting at said election voted, VOTED FOR THE STOCK LAW, the Court hereby declare the proposition to have been adopted, and after the expiration of thirty days from the date of this proclamation it shall be unlawful to permit hogs, sheep and goats to run at larger within the limits hereinbefore designated.

Accounts were allowed as are shown by the Minutes of Accounts.

We were adjourned to meet again Tuesday August 28th, 1957 at 9 o'clock A.M.
