

The Honorable Commissioners' Court of Sabine County met on April 27, 1953 at the regular meeting place in the office of the County Judge, Hemphill, Texas, with all members present, to-wit: O.A. Beauchamp, County Judge, H. H. Byley, Commissioner Prec. #1, W. T. Love, Commr. Prec. #2, Paul Lout, Commr. Prec. #3 and Earl Smith, Commr. Prec. #4, with Kyle D. Walker, Clerk of the Court.

Accounts were allowed as are shown by the Minutes of the "Accounts Allowed".

The following PETITIONS to add territory to areas now covered by the Hog Law were presented to the Court and upon motion By Earl Smith, Commr. Prec. #4 and seconded by W. T. Love, and carried by a vote of 4 to 0
Commr. Prec. #2, the following Hog Law Petitions were granted, to-wit:

TO THE HONORABLE COMMISSIONERS' COURT OF SABINE COUNTY, TEXAS:

We, the undersigned, constituting a majority of the owners of the hereinafter described lands in which there are less than twenty free holders, and which lands adjoin lands over which a stock law now prevails and in which hogs, sheep and goats are forbidden to run at large, hereby petition your honorable body to include the following lands or territory in said stock law territory and that you pass an order extending the stock law forbidding the running at large of hogs, sheep and goats to such territory, which is described as follows:

BEGINNING at a point in the north line of the Thomas Lindsey Survey at the N.E. corner of what is known as the C. A. Wood 160 acres and the northwest corner of Block No. 50 of the L.F. Bacon subdivision, said point being also in the south line of the A. G. Broom Survey; abstract No. 379; THENCE S. 81 E. about 1420 vrs. with the north line of the Thomas Lindsey Survey to the Northeast corner of said Thomas Lindsey Survey; THENCE S. 9 W. 768 vrs. to the southeast corner of Block No. 53 of the L. F. Bacon subdivision; THENCE N. 81 W. 706 vrs. to the S. W. corner of the said Block No. 53 of the L. F. Bacon Subdivision; THENCE S. 9 W. with the west line of Blocks 55 and 57 of said L.F. Bacon subdivision and on to the south line of said Thomas Lindsey Survey; THENCE N 81 W with the south line of said Thomas Lindsey Survey to the S. E. corner of a tract

of 32 acres owned by W. J. Barlow; THENCE N. 9 E. about 683 vrs. with the west line of Blocks No. 56 and No. 54 of the L.F. Bacon subdivision to an internal corner of Block No. 54; THENCE N. 81 W. 43 vrs. to another corner of said Block No. 54; THENCE N. 9 E. with the west lines of Blocks 54, 52 and 50 of said Bacon subdivision a distance of 861 vrs. to the place of beginning.

TO THE HONORABLE COMMISSIONERS' COURT
OF SABINE COUNTY, TEXAS:

WE, the undersigned, constituting a majority of the owners of the hereinafter described lands wherein there are residing less than twenty free holders, which land adjoins territory over which a stock law now prevails, and in which hogs, sheep and goats are not permitted to run at large, hereby petition your Honorable Body to include the following lands in said stock law territory and that you pass an order extending the stock law forbidding the running at large of hogs, sheep and goats, to include such lands, said lands so requested to be included in said stock law being described as follows:

BEGINNING at a point in the east line of the John Hailey Survey and the west line of T. & N. O. Section 16, which is South 16 1/4 East 38 varas from the south east corner of 150 acres of said Hailey Survey, formerly owned by Hiram Knox; Thence N. 88 3/4 E. with the north line of a tract of 72 acres originally conveyed by J.W. Minton to B. F. Chambers on September 18, 1924, to the center of the Hemphill and Fairdale Public Road; Thence northwesterly with the center of said Public Road to the most westerly southwest corner of 24 acres of said T. & N. O. Section 16, now owned by W. C. Smith, being also a corner of 139 acres of said Survey owned by P. P. Gandy; Thence North 1-1/2 West at about 57 varas to the Northwest corner of said W. C. Smith 24 acres; Thence N. 88 3/4 E. at 777 varas to corner in the east line of the west half of said T. & N. O. Section 16; Thence S. 1-1/4 E. with the East line of said T & N. O. Section 16 and the East line of 51 acres owned by Benena Ener and husband, N.W. Ener, to the S. E. Corner of said Ener 51 acres; Thence S. 88-3/4 W. at 610 varas to stake in the west line of the Henry Nichols League and the East line of the John Hailey Survey; Thence N. 16-1/4 W. with the said Hailey east line to the place of beginning.
