ORDER DECLARING RESULT of Bond Election

On this the 8 day of June, 1953, the Commissioners' Court of Sabine County, Texas, convened in regular session with the following members present, to-wit:

Love, Commissioner, Precinct No. 2, Paul Lout, Commissioner Precinct No. 3, Earl Smith, Commissioner Precinct No. 4, and the following absent: None, constituting a quorum, and among other proceedings, passed the following order:

There came on to be considered the returns of an election held on the 6 day of June 1953, in Rosevine Common School District No. 17, on the proposition of issuing bonds as provided in the order calling said election and it appearing that said election was in all respects legally held and that said returns were duly and legally made and that there were cast at said election 28 valid and legal votes, of which number there were cast:

"FOR THE ISSUANCE OF THE BONDS AND the levying of the tax in payment thereof" - - - - - 25 votes

"AGAINST THE ISSUANCE OF THE BONDS AND THE LEVYING OF THE TAX IN PAYMENT THEREOF" - - - - - 3 votes

IT IS THEREFORE found and declared and so ordered, by the Commissioners' Court of Sabine County, Texas, that a majority of the legally qualified property taxpaying voters who owned taxable property in said School District and who had duly rendered the same for taxation, voting at said election, voted for the issuance of said bonds and the levying of the tax in payment thereof, (a) and that therefore this Court is authorized to issue said bonds and to levy and have assessed and collected said tax in payment thereof.
