In Sabine County a Farm To Market Road is hereby designated extending from end of F. M. Road 944, 10 miles Southeast of Hemphill, Southeast, a distance of approximately 3.6 miles, subject to the availability of funds in the Farm-to-Market Road Fund as established by Senate Bill 287, 51st Legislature, and subject to the further condition that Sabine County will furnish all required right-of-way free of cost to the State.

Upon acceptance by the County and fulfillment of the condition of this order the State Highway Engineer is directed to proceed with construction in the most feasible and economical manner, at an estimated cost of \$61,200.00 and to assume the road for maintenance upon completion of construction.

TO THE HONORABLE COMMISSIONERS' COURT OF SABINE COUNTY, TEXAS:

We, the undersigned, constituting a majority of the owners of the hereinafter described lands in which there are less than twenty free holders, and which lands adjoin lands over which a stock law now prevails and in which hogs, sheep and goats are forbidden to run at large, hereby petition your honorable body to include the following lands or territory in said stock law territory and that you pass an order extending the stock law forbidding the running at large of hogs, sheep and goats to such territory, which is described as follows:

Beginning at the S. W. corner of 30 acres out of the J. H. Lamberth Survey owned by S. W. Tatom at a stake in the West line of said Lamberth's Survey; Thence Northerly with Tatom's West line to the N. W. corner of said Lamberth Survey; Thence Westerly to the S. E. corner of 138 acres owned by H. A. Jordan; Thence Northerly with Jordan East line to the N. E. corner; Thence Easterly to the S. E. corner of the Sturgis Lumber Company 54 acres; Thence Northerly with Sturgis East line to the Plainview and Yellowpine Public Road; Thence Westerly with said road to the N. W. corner of 26.26 acres now owned by A. C. Jordan; Thence Southerly with the West line of said A. C. Jordan tract and the H. A. Jordan 138 acres to the S. E. corner of the A. E. Hall 80 acres; Thence Westerly with Hall's South line of the extreme N. W. corner of a 54 acre tract and the N. E. corner of the Hall 12 acres tract; Thence Southerly with the West line of said 54 acre tract to the South line of the John Gilbert League; Thence Easterly with the South line of the John Gilbert League and the South line of the J. H. Lamberth Survey to the S. E. corner of the J. H. Lamberth Survey; Thence Northerly with the Lamberth East line to the N. E. corner of said Lamberth Survey; Thence Westerly with the Lamberth North line to the

N. E. corner of the S. W. Tatom 30 acres; Thence Southerly to the S. E. corner of the Tatom 30 acres; Thence Westerly to the place of beginning. RESPECTIVELY SUBMITTED.

It appearing to the Court that said petition is signed by a majority of the owners of the land therein described, and that no stock law now exists in said territory and that said territory adjoins lands in which a stock law now prevails, and in which hogs, sheep and goats are forbidden to run at large;

Upon motion duly made by Commissioner W. T. Love and seconded by Earl Smith, the vote being 4 for and 0 against, the petition was granted unanimously.

It is ordered by the Court that said petition be in all things granted and that the stock law forbidding the running at large of hogs, sheep and goats is hereby extended to include such territory and such territory is hereby declared to be included in territory wherein hogs, sheep and goats are forbidden to run at large, and from and after this date it shall be unlawful for hogs, sheep and goats to run at large in the territory described in above petition.

There being no further business, Court adjourned.
