I KNOW ALL MEN BY THESE PRESENTS: THAT WE, the undersigned who are owners COUNTY OF SABINE of real estate abutting and lying adjacent to that portion of the County Road, hereinafter referred to as Farm-to-Market Highway No. 2024, beginning at an intersection with SH No. 184 approximately four miles west of Hemphill and extending in a south westerly direction to Plainview on old Hwy. No. 8 a distance of 27,177 ft.

For and in consideration of the construction of a first class public road within the hereinafter described right-of-way, have granted conveyed, appropriated and dedicated to Sabine County Texas all those certain tracts or parcels of land situated along the above designated public road in Sabine County, Texas, within a right-of-way width of 80 ft., 40 ft., on each side of the centerline of designated Farm-to-Market road N. 2024 as surveyed by the District Engineer of the State Highway Department of Texas, from the South Right-of-Way line of State Hwy. No. 184, FM Road Sta. No. 0 / 87 for a distance of 27,137 feet, said centerline being more fully described as follows:

BEGINNING at a point on the south right-of-way line of State Hwy. No. 184. Said point being centerline Sta. No. 0 / 50 of Farm-to-Market Road N. 2024, and 50 feet S 17 deg. 15' W. of Centerline Sta. No. 335 / 78 of State Hwy. No. 184.

C. of an 5 deg. curve; THENCE 745.0 ft. around said 5 deg. curve having a central angle of 37 deg. 15' right and a tangent distance of 386.4 ft; THENCE N 84 deg. 56' W 3,877.0 ft. to the centerline of old Hwy. 8, Farm-to-Market Road No. 2024 station 271 / 87.0

It is the desire and intention of each of the undersigned land owners to dedicate for public road purposes, all real estate lying within the above described right of way; however, the said undersigned land owners respectively reserve and except to themselves, their heirs and assigns, all gas, oil and sulphur in and under their respective parcels of land herein dedicated for such right of way but waive all rights of ingress and egress thereon for the purpose of exploring, developing, mining or drilling for the same.

TO HAVE AND TO HOLD, the above described premises, subject to the mineral reservation above stated, together with all and singular the rights and appurtenances thereto in anywise belonging unto the said Sabine County, Texas and its assigns, and we, the undersigned land owners herein bind ourselves, our heirs, executors and administrators to warrant and forever defend, all and singular the said premises unto the said Sabine County, Texas and its assigns, against every person whomsoever lawfully claiming or to claim the same or any part thereof.

No. 8 a distance of 27,177 ft.

And that they and each of them by signing said instrument, having expressly declared that it is the desire and intention of each of them to dedicate for public road purposes all real estate lying within an 80 feet right of way described therein, in order that a first class public road can be constructed and maintained within said described right of way.

IT IS THEREFCRE ORDERED, ADJUDGED AND DECREED by the commissioners Court of Sabine, County, Texas, that the grant and dedication of said 80 feet right of way described in said instrument set forth above to Sabine County Texas be and the same is hereby accepted and said right of way shall hereafter constitute a first class public road and shall be available to the Texas Highway Department for the constitution of the proposed Farm-to-Market Highway No. 2024.

The above being read, it was moved and seconded that same do Pass.
