E. corner of same, Thence with B. H. Whites south boundary line to his S. W. Thence N. on West line to N. W. Corner of B. H. White Tract same being Odis Craddocks S. W. corner. Thence North on Craddocks west line to his N. W. corner at an old road, Thence with said old road to State Highway 184. Thence East with said Highway to another tract of H. M. Jordons at the N. W. corner of same. Thence south with the west boundary line of this tract to a 40 acre tract of Temple Lbr. Co. at its N. W. Corner Thence South with west line of this tract at the place of beginning.
