I hereby make application to you for authority for me to appoint an assistant or clerk in connection with the administration of the affairs of my office. I am serving as Justice of the Peace Precinct No. k, Sabine County, Texas, and I need an assistant or clerk to assist me in the performance of my duties. I am now receiving a salary of \$125.00 per month and I propose, should you authorize me to appoint an assistant or clerk, to ask you to reduce my salary to onehalf and to pay the amount of such reduction as a salary to my assistant or clerk. The total amount of fees, commissions and compensations collected by my office during the year 1955, was the sum of \$3,605.48, and the total amount collected by my office during the year 1956 to this date is \$2535.90. The total disbursments in the way of salaries and expenses for an assistant would be the sum of \$65.00 per month, and the total of the salaries and expenses paid to an assistant or clerk together with what salary I would then draw will not exceed the present expense of the office.

I respectfully request your authority for me to appoint such assistant or clerk to assist me in the performance of the duties of my office and that you fix the monthly compensation for such assistant or clerk. This application is made under the provisions of Article 3902 of the Revised Civil Statutes of Texas and I certify and swear the above facts are true and correct.
