Dear Sirs:

We, the undersigned residents of the Sabinetown community living on the extension of Farm-to-Market Road 1965, do hereby respectfully request that some action be taken in programming the unsurfaced portion of the above mentioned F. M. Road.

As you know, May 19, 1953, contract was let to Austin Road Company for the surfacing of .4.882 miles of F. M. 1965, from State Highway 87 in Hemphill to Forest Service Road No. 115, this leaving a section between surfaced F. M. 242 and recently surfaced F. M. 1965 unfinished.

This particular section is a school bus route and also a mail route. With only a few miles of surfacing the complete mail and bus route would be hard-surfaced since F. M. 1965 connects F. M. 242 and makes a loop back to Milam. The citizens would not only profit by the hard-surfaced road in the rainy winter months but also in the summer months when the dust is stifling, caused by the traffic of hunters and fishermen going to and from the river and local traffic count is relatively high at all times.

We would appreciate your early attention to this matter.
