It is unanimously ordered by the Court that Mrs. Floyd Smith be paid \$1200.00 a year to take care of Commodity Program Records for 1959, her salary to be paid out of General Emergency Fund.

It is the order of the Commissioner's Court of Sabine County, Texas, that from Jan. 1, 1959 to Jan. 1, 1960, the Precinct and County officers of Sabine County, shall continue to be paid on a Salary basis, according to Article XVI, Section 61 of the Constitution of the State of Texas, as amended, and that the compensation allowed each precinct and county officer by the Court shall be paid in twelve monthly installments or as the Court may hereafter direct. On Motion by W. T. Love and seconded by Earl Smith the Court unanimously voted that Sabine County remain on a Salary Basis for the year 1959.

The Court unanimously ordered the County Treasurer to deposit all fees and commissions appertaining to his office in the Officers Salary Fund plus fees and commissions paid to him by other officers and to withhold from the Jury Fund a total of \$1,595.76 and deposit same to the credit of Officers Salary Fund.

It is ordered by the Court ~~for~~ ^{that} the Treasurer transfer from the Road Districts to the General Emergency Fund the following amounts to meet Current Emergency Expenditures: Road

District #4-	1,000.00
District #5-	1,000.00
District #6-	1,000.00
District #9-	1,000.00
District #12-	1,000.00

The Court hereby orders the Treasurer to withhold from the Road & Bridge Special Fund and deposit to the credit of the Officers Salary Fund \$18,795.00, also the Treasurer is to deposit to the Officers Salary Fund all monies received from the State Comptroller that is supposed to be used for same.

It is the order of the Commissioner's Court of Sabine County that the First State Bank change the County Treasurer's account from Julian Smith to Jesse J. Moody.

There being no further business, Court adjourned.
