The Honorable Commissioner's Court, of Sabine County, Texas, met in regular session at the regular meeting place in Hemphill, Texas, on August 10, 1959, with all members of the Court present, to-wit: O. A. Reauchamp, County Judge, H. W. Wright, Commr. Prect. #1, W. T. Love, Commr. Prect. #2, Paul Lout, Commr. Prect. #3, and Earl Smith, Commr. Prect. #4 and Kyle D. Walker, Clerk of the Court.

Accounts were allowed as are shown by the Minutes of Accounts Allowed.

There came before the Court the matter of changing a portion of the boundary line between Commissioners Precinct No. 4 and Commissioner Precinct No. 3, change that portion of said boundary line which formerly ran from a point in front of the Hamp Pratt Residence about 38 vrs West of the fork of the two public roads, one leading from the Hamp Pratt residence to Geneva and the other leading from the Hamp Pratt residence to Milam, and following Westerly with said road to Pologocho Creek.

Upon motion of Commissioner W. T. Love, and seconded by Commissioner H. W. Wright, and carried unanimously, the Court approved the change in said portion and said boundary line so that the boundary between said points shall hereafter be located as follows:

Beginning in the public road near the Hamp Pratt residence where the public road leading from the Hamp Pratt residence to Geneva and the public road leading from the Hamp Pratt

residence to Milam form a fork; THENCE in an Easterly direction with the South margin of that fork of the road leading to Milam, a distance of 38 vrs to the East line of the Hamp Pratt homestead tract; THENCE Southerly with the East line of the Hamp Pratt. tract and the West line of the H. E. McGown homestead to the S. E. corner of said Pratt tract and the S. W. corner of said McGown tract at a corner in the North line of a portion of the Naomi Mackey Survey owned by T. V. Parker; THENCE Easterly with Parker's North line to the N. E. corner of said Parker's tract; THENCE Southerly with Parker's East line to the S. E. corner of Parker's tract in the South line of the Mackey Survey; THENCE Westerly with Parker's South line and P. H. McGown's North line to the N. E. corner of the Jack McCoy 20 acres in the North line of the F. M. Errington Survey; THENCE Southwesterly with the East line of the McCoy 20 acres and the West line of P. H. McGown's lands to the S. E. Corner of the McCoy 20 acres in the South line of said Errington Survey; THENCE with McCoy's South line, being the South line of the Errington Survey in a Northwesterly direction to the N. E. corner of the James McMichael 122 acrestract of land; THENCE in a Southwesterly direction with the East line of McMichael 122 acre tract to the S. E. corner of said McMichael tract on the North bank of Pologocho Creek; THENCE up said Pologocho Creek with its meanders and on the North bank thereof to a point North of the N. E. corner of Matthew Dennis: 40 acre tract which lies on the South side of Pologocho Creek; THENCE South to center of said Pologocho Creek and intersecting the original divisional line between Precinct No. 4 and Precinct No. 3.

Upon motion duly had and carried the County Treasurer is directed by the Court to close the following Road Districts and transfer the balances in these accounts to the county's General Emergency Fund; Road Districts #3- #7- #9 and #13.

There being no further business court adjourned.
