It is the order of the Commissioner's Court of Sabine County, Texas, that from Jan. 1, 1961 to Jan. 1, 1961, the Precinct and County Officer's of Sabine County, shall continue to be paid on a Salary Basis, according to Article XVI, Section 61 of the Constitution of the State of Texas, as amended, and that the compensation allowed each precinct and county officer by the Court shall be paid in twelve monthly installments or as the Court may hereafter direct. On Motion by W. T. Love and seconded by H. W. Wright the Court Unanimously voted that Sabine County remain on a salary basis for the Year 1961.

The Court Unanimously agreed to cut Justice of the Peace, Ira McLemore, salary to One thousand, one hundred and fifty-two (\$1,152.00) per year.
