WHEREAS, Federal financial assistance has been made available to certain areas under Public Law 87-27; May 1, 1961, and

WHEREAS, Sabine County, Texas, has been designated as one of the areas for which such public assistance is available, and

WHEREAS, one of the statutory requirements of Public Law 87-27 states that there must be some organization set up to represent such area or combination of areas on an areawide basis, and

WHEREAS, it is a further statutory requirement of Public Law 87-27 that said organization shall prepare an Overall Economic Development Program for the Total Area to be represented, and

WHEREAS, there is in existance an organization known as the Deep East Texas Development Association, with offices located at San Augustine, Texas, which was and is organized for the specific purpose of giving assistance in development of Deep East Texas area resources.

THEREFORE, BE IT RESOLVED, that the Commissioners Court of Sabine County, Texas, does hereby recognize the Deep East Texas Development Association as being representative of the

County of Sabine, Texas, in, and only in, the capacity of representing said County or Local County Community Groups for the purpose of clearing with the Area Redevelopment Administration local projects for which the County or groups within the County may desire to seek Federal financial assistance under provisions of Public Law 87-27, and

BE IT FURTHER RESOLVED, that recognition of the Deep East Texas Development Association in such capacity shall in no way bind the County of Sabine, Texas, or any group within the County of Sabine, Texas, for any financial obligation in support of the Deep East Texas Development Association except as such assistance shall be gratned under further and separate resolution or action of said County or group, and

BE IT FURTHER RESOLVED, that such recognition of the Deep East Texas Development Association as representative of the County of Sabine, Texas shall in no wise require said County or any group within said County to seek Federal assistance for any project under Public Law 87-27 except as such County or group within such County shall desire to seek assistance after due consideration upon the Local County Area Level.
