Upon a motion by W. T. Love, seconded by Earl Smith, the court unanimously voted "AYE" to accept the resignation of Walter Smith, Deputy Sheriff, effective March 3, 1963.

Upon a motion by W. T. Love, seconded by Earl Smith, the court unanimously voted to give Lois Smith, Commodity Program Representative, a raise in salary from \$100.00 per month to \$200.00, effective as of February 1, 1963.

PETITION TO ADD ADJACENT TERRITORY TO EXISTING
STOCK LAW TERRITORY

TO THE HONORABLE COMMISSIONERS COURT OF SABINE COUNTY, TEXAS:

We, the undersigned persons constitute a majority of the owners of the hereinafter described lands which adjoin lands of which a stock law now prevails and in which horses, mules, jacks, jennets, donkeys, hogs, sheep and goats are not permitted to run at large, hereby petition this Honorable Body to include in said existing stock law territory the following described territory in which there are less than twenty freeholders, and that you pass an order extending the stock law forbidding the running at large of horses, mules, jacks, jennets, donkeys, hogs, sheep and goats, to include the hereinafter described lands, said lands requested to be included in said stock law being described as follows:

BEGINNING at a stake in the South line of the Sion Smith League at the S. W. corner of U. S. Forest Service Tract No. S 13e; THENCE N 35 E with the West line of said Forest Service Tract to the N. W. corner of same; THENCE S 58 E with the North line of said Forest Service Tract to its N. E. corner in the West line of the U. S. Forest Service Tract No. S1A1; THENCE N 32 E with the West line of said tract S1A1 to the N. W. corner of said Forest Service Tract; THENCE S 58 E with the North line of said Forest Service Tract S1A1 to the S. W. corner of a tract of 28 acres owned by J. M. Travis at the S. E. corner of the W. H. Morrison 28 acres; THENCE N 32 E with the Travis West line to the Housen Bayou; THENCE down the Housen Bayou with its meanders to the N. W. corner of 100 acres of the Sion Smith League owned by the Heirs of W. E. Coussons, deceased; THENCE S 19-3/4 W with Coussons' West line to his South corner in the East line of the Sion Smith League; THENCE S 32 W with Sion Smith East line to the S. E. corner of the Sion Smith League, being also a corner of U. S. Forest Service Tract S14a; THENCE N 58 W with the South line of the Sion Smith League, being also the South line of tracts S 14a and S 1A1 and S13e to the place of beginning,




