The Court then proposed the following resolution:

WHEREAS, Sabine County exercises certain control over that certain part of U.S. Highway No. 96 within said county, and within McGee Bend Reservoir area, being further described as follows: Beginning at Highway Station 38+95 in the town of Brookeland, Texas and extending approximately 3.28 miles north to Highway Station 21+38, and being that portion of U.S. Highway No. 96 which lies with the bounds of McGee Bend Reservoir project, being constructed by U.S. Corps of Engrs. and as shown on plat or map Exhibit "A" prepared by the Texas Highway Department;

AND, WHEREAS SAID 3.28 miles portion of said Highway U.S. 96 is subject to inundation as a result of the construction of McGee Bend Dam by the U.S. Corps of Engineers;

AND, WHEREAS a new highway has been constructed on a higher elevation and opened to and being used by the general public;

NOW, THEREFORE, be it resolved that said 3.28 mile portion of U.S. Highway No. 96 be abandoned by the County of Sabine, State of Texas.

Upon the resolution being read, it was moved and seconded that it pass and be adopted by said Court. Thereupon, the question being called for, the following members voted "AYE":
