Fees for impounding and fines for violations of the stock law would compensate the county for hiring a special deputy. The Sheriff is not equipped and not able to expend the travel and time necessary to achieve desired enforcement of the stock law. 4.

THEREFORE, we petition that this action be taken immediately, since an emergency exists in potential and probable damage to our property, as well as a continuing situation which makes the law a nullity in our community.
