NOTICE TO THE PUBLIC OF PROPOSED ELECTION
PRECINCT CHANGES

WHEREAS, it has been recommended to the Commissioner's Court of Sabine County, that certain changes be made in the voting precincts of Sabine County, Texas, as follows:

- (1) FAIRDALE VOTING PRECINCT NO. 2, to be combined with and made a part of FAIRMOUNT VOTING PRECINCT NO. 12.
- (2) Bayou voting Precinct Number 13, to be combined with and made a part of Yellowpine Voting Precinct Number 7.
- (3) Time Voting Precinct Number 17 to be combined with and made a part of Isla Voting Precinct No. 10.
- (4) Sabinetown Voting Precinct Number 14 to be combined with and made a part of Hemphill Voting Precinct No. 1.
- (5) Gravel Hill Voting Precinct Number 16, to be combined with and made a part of Hemphill Voting Precinct No. 1.
