Love and seconded by Commissioner Earl Smith and with all members voting "AYE" the following Order of Voting Precinct Change and the following Notice of Voting Precinct Change were passed by the Court and the County Judge and County Clerk were instructed to sign them and have the Notice of Voting Precinct Change published in the Sabine County Reporter for three weeks.

ORDER OF COMMISSIONERS  
COURT OF SABINE COUNTY, TEXAS

Whereas after careful study and consideration of the voting precincts of Sabine County, Texas, it appears to the court that it would benefit the people of the county as a whole and that there would be a saving in election expenses to make the changes in the voting precincts as hereinafter set forth;

Whereas the population shifts and changes in certain areas of the county have made the hereinafter changes in the voting precincts desirable;

Whereas, the Sabine County Democratic Executive Committee has requested that the hereinafter changes in the voting precincts be made;

Upon a motion being made by W. T. Love and seconded by Earl Smith, the following order was passed by the following vote of:

It is hereby ordered by the Commissioners Court of Sabine County, Texas sitting in regular session on this 22nd day of August, 1966, and acting under the authority of Article 2.04 of the Texas Election Code, that the voting precincts of Sabine County, Texas be changed and modified as follows:

(1) Voting Precinct No. 2, being the Fairdale Voting Precinct shall be combined with and made a part of the Fairmount Voting Precinct Number 12; and voting Precinct Number 12 shall henceforth be described as follows:

Beginning at the Southeast corner of Sabine County where the South line of said county intersects the Sabine River;

Thence Westerly along the South line of Sabine County, being the Sabine - Newton County line to the intersection of said county line with the West line of the Alex Gilmer Survey A-441;

Thence Northerly along the West line of the Gilmer Survey to the Southwest corner of the John Gallion Survey A-17;

Thence Northerly along the West line of the John Gallion Survey to its Northwest corner;

Thence Easterly along the North line of said Gallion Survey to the Southwest corner of the T&NO Ry. Co. Survey A-418;

Thence Northerly along the T&NO Ry. Co. Survey's West line to the Scrapping Valley Road;

Thence Northerly along said road to Six Mile Creek;

Thence Easterly and down said creek to the Northeast corner of the D. L. Richardson Survey A-180;

Thence Southerly along the East line of said Richardson Survey and continuing on the same course to the Southwest corner of the Robert Russell Survey A-52;

Thence Easterly along the South line of said Russell Survey to the Northeast corner of the same; ~~continuing Northerly to the~~

Thence Northerly along the East line of said Russell Survey to the Northeast corner of same and continuing Northerly to the Northwest corner of the H.E.&W.T. Ry. Co. Survey A-273;

Thence Easterly along the North line of said H.E.&W.T. Ry. Co. Survey A-273 to the Northeast corner of the same;

Thence Southerly along the East line of said H.E.&W.T. Ry. Co. Survey to the Northwest corner of the H.E.&W.T. Ry. Co. Survey A-273 and the Southwest corner of the John S. Chivalal Survey A-187;

Thence Easterly along the South line of the Chivalal Survey to the Northeast corner of the H.E.&W.T. Ry. Co. Survey A-273 and the Northwest corner of the E. M. Carlton Survey;

Thence Southerly along the West line of the E. M. Carlton Survey to the North line of the Henry Canfield League A-4;

Thence Easterly along the North line of the said Canfield Survey to the Sabine River;

Thence Southerly and down the Sabine River to the place of beginning;

and all qualified voters living within the area formerly known as Fairdale Voting Precinct No. 2 shall, beginning February, 1967 (the beginning of the next election year), vote as a part of Fairmount voting Precinct Number 12 at the duly selected polling place of said Precinct Number 12.

(2) Voting Precinct Number 14, being Sabinetown Voting Precinct and Voting Precinct Number 16, being Gravel Hill Voting Precinct shall be combined with and made a part of Hemphill Voting Precinct Number 1; and Hemphill Voting Precinct Number 1 shall henceforth be described as follows:

Beginning at the mouth of Palo Gaucho Creek, where the said Palo Gaucho Creek empties into the Sabine River;

Thence down the Sabine River in a Southerly direction to a point where the said Sabine River intersects the East line of the G. L. Bourland Survey;

Thence Northerly with the East line of the G. L. Bourland Survey to its Northeast corner;

Thence Westerly along the North line of the G. L. Bourland Survey to the Northwest corner of the same, which corner is on the East line of the Jesse Low Survey Abstract No. 147;

Thence Northerly with the East line of the Jesse Low Survey to the Northeast corner of said survey;

Thence Westerly along the North line of the Jesse Low Survey A-147 to the Northwest corner of the same, which corner is in the East line of the Henry Nichols Survey, A-46;

Thence Southerly with the East line of the Henry Nichols Survey A-46 to Houssen Bayou, where said bayou intersects the East line of said survey;

Thence in a Westerly direction up the Houssen Bayou to a point where the said bayou intersects the East line of the John Haley Survey;

Thence Southerly along the East line of the John Haley Survey to the Southeast corner of said survey;

Thence Westerly along the South line of the John Haley Survey to a point where the John Haley South line meets the East or Southeast line of the Sion Smith Survey;

Thence Southeasterly along the Southeast line of said Sion Smith Survey to the most Southerly Southeast corner of said Sion Smith Survey;

Thence Northwesterly along the Southwest line of the Sion Smith Survey to the Northeasterly corner of the John Quinalty Survey; ~~East line~~

Thence Southerly with the John Quinalty Survey East line to the Southeast corner of said Quinalty Survey;

Thence Northwesterly along the South line of the Quinalty Survey to the Southwest corner of the same;

Thence Northerly to the Southeast corner of the Susan McLeod Survey;

Thence Westerly along the South line of the said McLeod Survey to the Southwest corner of the same;

Thence Northerly along the West line of the McLeod Survey to the Southeast corner of the Isaac F. Pace Survey;

Thence Northwesterly along the South line of the said Pace Survey to the Northeast corner of the John Saddler Survey A-300;

Thence Southerly along the East line of said Saddler Survey to its Southeast corner;

Thence Northwesterly along the South line of the said Saddler Survey and the South line of the R. H. Dent Survey A-357 to the Southwest corner of the R. H. Dent Survey; and a corner of the James Low Survey A-341;

Thence Northwesterly along the James Low Survey line to an interior corner of said Low Survey;

Thence Southerly along the most Westerly East line of the James Low Survey to the Most Southerly corner of said survey;

Thence Northerly along the extreme West line of the James Low Survey A-341 to where the same intersects the Tatom Road Road;

Thence Northwesterly with said road to a point where the same intersects the North line of the H. A. Jordan 140 acre tract in the John Gilbert Survey;

Thence Easterly along the North lines of the said H. A. Jordan 140 acre tract and the W. T. Jones 22 acre tract and the W. T. Jones 100 acre tract to the Northeast corner of said Jones 100 acre tract;

Thence Northerly to the Northwest corner of the Tatom 110 acre tract;

Thence Easterly along the Tatom 110 acres to the Northeast corner of the same;

Thence Northerly along the West line of the Tatom 110 acre tract to the Northwest corner of the same;

Thence Northerly to the Northwest corner of the Dewey Tatom 26 acre tract;

Thence Easterly along the North lines of the W. C. Tatom 26 acres; the Temple Industries 98 acres and the D. B. Speights et al 123 acre tracts to the East line of the John Gilbert Survey;

Thence Northerly along said Gilbert East line to Watt's Creek, a tributary of Housen Bayou;

Thence Easterly along and down said creek to the West line of the J. A. Travis 100 acres in the John Clark Survey A-7;

Thence Northerly along the West line of said Travis 100 acres to its Northwest corner;

Thence Easterly along the North line of the said Travis 100 acres to the Northeast corner of said tract;

Thence Southerly along the East line of said Travis 100 acres to Watts Creek;

Thence Easterly and down said creek to its intersection with Housen Bayou and continuing down said bayou to a point where the same intersects the East line of the John Clark Survey A-7;

Thence Northerly along the East line of said Clark Survey to the Northwest corner of the Temple Industries, Inc., et. al. 200 acre tract in the Robert N. Smith Survey;

Thence Easterly along the North line of said Temple Industries, et. al. 200 acre tract to the West line of a tract of 120 acres owned by Temple Industries;

Thence Easterly to its Northeast corner;

Thence Northerly to the Southeast corner of the Henry S. White Survey A-224;

Thence Northeasterly along the East line of said White Survey to the North corner of the same;

Thence Northwesterly along the North line of said White Survey to a corner of the M. E. Griffin Survey A-320;

Thence Northwesterly along the most westerly line of the said Griffin Survey to the most Northerly Northwest corner of said Griffin Survey;

Thence Northerly along the Northwest line of the Mary J. Brumley Survey A-312 to the most Northerly S.E. corner of said Brumley Survey;

Thence Northwesterly along the Northeast line of the Mary J. Brumley Survey to the most Northerly corner of said Brumley Survey;

Thence Southerly along the West line of said Brumley Survey to the Hemphill

Bronson Highway No. 184;

Thence Westerly along said Highway to the point where the Farm Road Number 2024 intersects the same;

Thence Southwesterly along the Farm Road 2024 to a point where the same crosses the most Northerly South line of the John Clark Survey A-7;

Thence Westerly along the most Northerly South line of said Clark Survey to the most Westerly Southwest corner of said Survey;

Thence Northerly along the extreme West line of said Clark Survey to the most Northerly Northwest corner of the said Clark Survey;

Thence Easterly along the extreme North line of said Clark Survey to the Southwest corner of the G.C. & S.F. Railway Co. Sec. 14, A-438;

Thence North along the West line of the G.C. & S.F. Railway Co. Sec. 14, A-438 to an interior corner of said Survey;

Thence Westerly along the most Northerly South line of the G.C. & S.F. Railway Co. Survey Sec. 14, A-438 and the South line of the William Donahoe Survey to the Southwest corner of said Donahoe Survey;

Thence North along the West line of said Donahoe Survey to the Northwest corner of the same;

Thence Easterly along the North line of said Donahoe Survey to the Southwest corner of the Joseph Mott Survey;

Thence Northwesterly along the West line of the Mott Survey to the most Westerly corner of said Mott Survey;

Thence Easterly and Northerly along the West line of the Joseph Mott Survey to the Southwest corner of the Nathaniel Hamilton Survey A-123;

Thence Northerly along the West line of said Hamilton Survey to its Northwest corner;

Thence Easterly along the North line of the Hamilton Survey and the South line of the Naomi Mackey Survey to Palo Gaucho Creek;

Thence Southeasterly and down said creek to the North line of the William Clark Survey A-8;

Thence Easterly along the North line of the said William Clark Survey to its Northeast corner;

Thence Southerly along the East line of the said Clark Survey to Palo Gaucho Creek;

Thence Easterly and down said Palo Gaucho Creek to the place of beginning.

And all qualified voters living within the areas formerly known as Sabinetown Voting Precinct Number 14 and Gravel Hill Voting Precinct Number 16 shall, beginning February, 1967 (the beginning of the next election year), vote as a part of Hemphill Voting Precinct Number 1 at the duly selected polling place of said Precinct Number 1.

3. Voting Precinct No. 13, being Bayou Voting Precinct shall be combined with and made a part of the Yellowpine Voting Precinct No. 7, and Voting Precinct No. 7, shall henceforth be described as follows:

BEGINNING at the N. E. Corner of the Henry Canfield Survey A-4, on the Sabine River;

THENCE Westerly along the N. line of said Canfield Survey to the SW corner of the E. M. Carlton Survey, A-265;

THENCE N along the W. line of said Carlton Survey to its NE corner in the S line of the John S. Chival Survey, A-187;

THENCE Westerly along the S line of said Chival Survey to the SW corner of the same;

THENCE N along the W line of said Chival Survey to the NW corner of the same in the S line of the G. L. Bourland Survey A-2;

THENCE Westerly along the S line of said Bourland Survey to its SW corner in the E line of the H. E. & W. T. Ry. Co. Survey, A-273;

THENCE Southerly along the East line of the said H. E. & W. T. Survey and continuing the same course along the East line of the Robert Russell Survey to the SE corner of said Russell Survey;

THENCE Westerly along the S line of said Russell Survey to its SW corner;

THENCE Northerly along the W line of said Russell Survey to the S line of the Eli Low Survey, A-34;

THENCE Westerly along the S line of the Eli Low Survey to Six Mile Creek;

THENCE Westerly and up Six Mile Creek to the West line of the Walter Hughes Survey, A-24;

THENCE Northerly along the W line of said Hughes Survey to the NW corner of the same and the most Southerly corner of the R. F. Gilbert Survey, A-337;

THENCE Northwesterly along the SW line of said Gilbert Survey to its most Westerly corner;

THENCE N along its West line past its NW corner and continuing on the same course to an interior corner of the M. A. Lowe Survey, A-275;

THENCE Northwesterly to the SW corner of the H. T. & G. Ry. Co. Survey, A-467;

THENCE Northeasterly along the W line of said H. T. & G. Ry. Co. Survey to the S line of the William W. Davis Survey A-89;

THENCE Northwesterly along its SW line to its SW corner;

THENCE Northeasterly along its W line to its most Northerly corner;

THENCE Southeasterly along the N line of said Davis Survey to the SE corner of the Sion Smith Survey, A-55;

THENCE Northeasterly along the Smith E line to the SW corner of the John Haley Survey;

THENCE Easterly along the Haley Survey S. line to its SE corner;

THENCE Northerly along the E line of said Haley Survey to Housen Bayou;

THENCE Easterly and down said Bayou to the E line of the Henry Nichols Survey, A-46;

THENCE Northerly along the Nichols E line to the NW corner of the Jesse Low Survey, A-147;

THENCE Easterly along the N line of said Low Survey to its NE corner;

THENCE Southerly along the Jesse Low East line to the NW corner of the G. L. Bourland League;

THENCE Easterly along the N line of said Bourland Survey to the NE corner of the same;

THENCE Southerly along its E line to the Sabine River;

THENCE Southerly and down said Sabine River to the PLACE OF BEGINNING:

and all qualified Voters living within the area formerly known as Bayou Voting Precinct No. 13, shall, beginning February, 1967, (the beginning of the next election year) vote as a part of Yellowpine Voting Precinct No. 7, at the duly selected polling place of said Voting Precinct No. 7.

4. Voting Precinct No. 17, being Time Voting Precinct shall be combined with and made a part of the Sexton Voting Precinct No. 5, and Voting Precinct No. 5, shall henceforth be described as follows:

BEGINNING at the Mouth of Martinez Bayou where the same empties into the Sabine River;

THENCE Westerly and up the said Martinez Bayou to a point for corner in the Joseph W. Brittain Survey, where the said Bayou intersects the Sabine-Shelby County line;

THENCE Southeasterly along the Sabine-Shelby County line to a point where the said Sabine-Shelby County line meets the San Augustine County line;

THENCE Southerly along the Sabine County West line to the divisional line of the E. A. Lloyd Survey, A-151;

THENCE Easterly along said divisional line to the East line of said Lloyd Survey;

THENCE S along the E line of said Survey to the N line of the David Renfro Survey;

THENCE EAST along the N line of the said Renfro Survey to its NE corner;

THENCE S along the W line of said Renfro Survey to Mine Creek;

THENCE Easterly along said Creek to a point where the same intersects the NE corner of the William Isaacs Labor A-133;

THENCE Northerly along the W line of the William Defee Survey, A-86 to the Defee NW corner; and the SW corner of the Richard Slaughter Survey, A-53;

THENCE Easterly along the South line of the said Slaughter Survey to its SE corner;

THENCE Easterly and the same course to Reeves Creek;

THENCE Easterly and down said Creek to the West line of the William Speights Survey A-193;

THENCE S along the W line of said Speights Survey to the Carter's Ferry Road, now known as F. M. No. 276;

THENCE NORTH easterly along said road to a point in the S. M. Lord Survey where the said Carter's Ferry Road intersects the South line of the S. M. Lord Survey, A-241;

THENCE Northeasterly along the S line of said S. M. Lord Survey and continuing on the same course to the Sabine River;

THENCE Northerly and up said Sabine River to the PLACE OF BEGINNING;

and all qualified voters living within the area formerly known as Time Voting Precinct No. 17, shall, beginning February, 1967, (the beginning of the next election year) vote as a part of Sexton Voting Precinct No. 5, at the duly selected polling place of said Voting Precinct No. 5,

#### NOTICE OF VOTING PRECINCT CHANGE

NOTICE is hereby given of the following changes in the Voting Precincts of Sabine County, Texas, which changes were made by Order of the Commissioner's Court of Sabine County, Texas, dated August 22, 1966; to-wit;

(1) Voting Precinct Number 2, being the Fairdale Voting Precinct has been combined with and made a part of Fairmount voting precinct Number 12, and all qualified voters residing within the area formerly encompassed by Fairdale Voting Precinct Number 2 shall, beginning in the year, 1967, vote as a part of Fairmount voting Precinct Number 12, at the duly selected polling place at said Fairmount Voting Precinct No. 12.

(2) Voting Precinct Number 14, being Sabinetown voting precinct and Voting Precinct Number 16, being the Gravelhill voting Precinct, have been combined with and made a part of Hemphill Voting Precinct No. 1, and all qualified voters residing within the areas formerly encompassed by Sabinetown Voting Precinct No. 14, and Gravelhill Voting Precinct No. 16, shall, beginning in the year, 1967, vote as a part of Hemphill voting Precinct No. 1, at the duly selected polling place at said Hemphill voting precinct No. 1.

(3) Voting Precinct Number 13, being the Bayou voting precinct has been combined with and made a part of Yellowpine voting precinct No. 7, and all qualified voters residing within the area formerly encompassed by Bayou voting precinct Number 13, shall, beginning in the year, 1967, vote as a part of Yellowpine voting precinct Number 7, at the duly selected polling place at said Yellowpine voting precinct Number 7.

(4) Voting Precinct Number 17, being Time voting precinct has been combined with and made a part of Sexton Voting precinct No. 5, and all qualified voters residing within the area formerly encompassed by Time Voting Precinct Number 17, shall, beginning

in the year, 1967, vote as a part of Sexton voting precinct Number 5, at the duly selected polling place at said Sexton Voting Precinct Number 5.

The above changes were adopted by the Commissioner's Court of Sabine County, Texas, by virtue of the authority vested in said Commissioner's Court by Article 2.04 of the Texas Election Code.

The above changes will not become effective until the beginning of the next voting year, being the year, 1967.
