Wright that the Sabine County Commissioners' Court accept the provisions contained in Minute Order No. 59807 passed by the State Highway Commission on August 1, 1967, for the improvement by the Texas Highway Department of the roads described below and that Sabine County agrees to furnish all required right-of-way free of cost to the State:

From State Highway 21, 3.0 miles west of the Sabine River, South across Palo Gaucho Bayou to an intersection with an existing county road a distance of approximately 2.8 miles.
