The Court approved and signed the following Order of Stock Law Election:

ORDER OF ELECTION

On this the 23rd day of September, 1968, came on to be heard by the Commissioners'

Court of Sabine County, Texas, at this the next regular term of such Court, after the filing of the petition of 267 freeholders of Sabine County, Texas, filed herein on the 9th day of September, 1968, praying that this Court order an election to be held in Sabine County for the purpose of enabling the freeholders thereof to determine whether cattle shall be permitted to run at large therein, and also for the purpose of enabling the freeholders thereof to determine whether, horses, mules, jacks, jennets, donkeys, hogs, sheep and goats shall be permitted to run at large therein, and such petition being heard, and it appearing to the Court that such petition is in due form, that no election for such purpose has ever been carried for the entire county, that no election to determine said questions has been held herein within twelve months prior to the filing of such petition, and that such petition should be granted, it is accordingly ordered that on the 5th day of November, 1968, such date being not less than thirty days from the date hereof, an election shall be held throughout Sabine County for the purpose of enabling the freeholders of Sabine County to determine whether cattle shall be permitted to run at large in Sabine County, and also for the purpose of enabling the freeholders of Sabine County to determine whether horses, mules, jacks, jennets, donkeys, hogs, sheep and goats shall be permitted to run at large in Sabine County, and that such election shall be held and conducted and the returns thereof made in accordance with the laws regulating general elections, in so far as the same are applicable, and the laws applicable to elections to determine whether cattle shall be permitted to run at large and whether horses, mules, jacks, jennets, donkeys, hogs, sheep and goats shall be permitted to run at large, where not in conflict with the general law, and the County Judge shall issue the order therefor, cause public notice thereof to be given, as provided by law, and order, and where advisable, provide forms for, and cause to be duly attended to, publication and return of notice of election and delivery and return of writs of election.
