CONSENT TO TERMINATION OF EASEMENT

WHEREAS, on November 8, 1968, the United States of America, acting by and through the Forest Service, United States Department of Agriculture, executed an easement conveying a right of way across certain land in Sabine County, Texas, to the County of Sabine, State of Texas, which easement is recorded in Volume 133, Pages 655-659, Deed Records, Sabine County, Texas, reference to said easement and the record thereof is hereby made for a more complete description of said right of way and the terms thereof; and

WHEREAS, said easement dated November 8, 1968, provided that the Chief Forest Service, may terminate said easement, or any segment thereof, by consent of the Grantee; and

WHEREAS, it has been determined by the Commissioners Court of Sabine County that the entire right of way area conveyed by said easement dated November 8, 1968, is now included in an easement for State Road FM 2928 and is no longer needed by the County for its public purposes; and

WHEREAS, the Commissioners Court of Sabine County, by an order, has duly authorized and directed the undersigned County Judge of Sabine County to execute and deliver this Consent to Termination Easement in the name of Sabine County, which order has been entered upon the minutes of the Commissioners Court of Sabine County.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the County of Sabine, State of Texas, hereby consents to the termination of the herein above described easement by the Chief, Forest Service, United States Department of Agriculture.
