Motion by Commissioner H. E. Wilburn, seconded by Commissioner, R. E. Smith and with all voting "AYE" the Court directed the County Treasurer to transfer 50% of funds received from U. S. Forest Service to County Board of Education for distribution to Schools according to law. The County Treasurer was also directed to prorate the remainder of the funds to the various Precincts at 25% to each Precinct after the Treasurer has deducted his commission.

Harborlight Resolution

On motion made by R. E. Smith and seconded by T. A. Seales the following resolution was adopted:

That upon request of the owner and developer of Harborlight Subdivision on the Moses Hill Survey in Sabine County, Texas, the roads in said subdivision which were heretofore dedicated as public roads by the said owner on February 9, 1970, are hereby declared to be abandoned as public roads by Sabine County, Texas; and any interest in said roads that has heretofore vested in Sabine County, Texas shall revert to the owner thereof, Douglas Haygood, for the use and benefit of himself and the owners of the lots in said subdivision.

RESOLUTION

WHEREAS, the County of Sabine is in full support of community alcoholism services and has experienced severe problems in this regard, and,

WHEREAS, it is found that the Deep East Texas Council of Governments is attempting to phrovide services by use of funds available through the Texas Commission on Alcoholism by obtaining a grant therefrom. The County being in favor of such services and said grant for use in community alcoholism services, and,

WHEREAS, the County will contribute to said grant as stated on Exhibit A attached to and now a part of this resolution, and,

WHEREAS, such services as to be provided by the Deep East Texas Council of

Governments to the County of Sabine in the Community Alcoholism Services Center Grant are as follows:

- (a) Individial Counseling
 (b) Group Counseling
 (c) Family Counseling
 (d) Vocational Counseling
 (e) Follow-up Services
 (f) Coordination of Existing Programs, and

WHEREAS, the Commissioners Court authorizes the County Judge of the County of Sabine to sign this resolution favoring such services as the Community Alcoholixm Services Center's grant will provide and place the same on the minutes of the Commissioners Courts.

County Judge, Sabine County,

The County of Sabine Egrees to provide the following in support of the Community Alcoholism Services Center Project:

- 1. 150 square feet of office space which will be used one (1) eight (8) hour day a week for one (1) year
- 2. Janitorial and utilities cost for the office space
- 3. One (1) desk
- 4. Four (4) chairs
- 5. One (1) lamp
- 6. One (1) small filing cabinet
- 7. Access to use of a typewriter
- 8. Access to use of a copying machine.

Motion by Commissioner T. A. Seales, seconded by Commissioner, H. E. Wilburn the Court approved the Bond & Oath of Henry H. Poindexterk Deputy Constable, Justice Precinct No. 3.

All accounts were allowed and made payable.

There being no further business, the Court adjourned.
