Motion by Commissioner, Paul Lout, seconded by Commissioner R. E. Smith, and by unanimous consent the Court appointed Mrs. A. O. Wolf Presiding Judge and E. G. Dorsey as Alternate Presiding Judge for the Special Election For Mayor and City Councilmen of Bronson, Texas to be held August 11, 1973, and Presiding Judge was authorized 4 election clerks to assist in the election.

ORDER CALLING SPECIAL ELECTION

On motion by R. E. Smith, seconded by H. E. Wilburn, the following order calling a Special Election for city officials of the town of Bronson, Texas was unanimously adopted by the Court on June 29, 1973;

A petition bearing the names of at least twenty-six (26) tax paying voters living in the town of Bronson, Texas having been presented to the Court requesting a special election be called for the election of a Mayor and five Alderman for the town of Bronson, Texas, pursuant to article 990, V. A. T. S., it is accordingly ordered, as required by Article 990, V. A. T. S., that a special election be held in the town of Bronson, Texas, on Saturday, August 11, 1973, to elect a Mayor and five Alderman for the town of Bronson, Texas. The Clerk of the Court shall give notice of said election of not less than ten days in the usual manner provided for such elections and which election shall be held in like manner as similar elections and the officers so elected shall in like manner be qualified and installed.
