On this the 17th day of September, 1973, the Honorable Commissioners' Court met in a Special Session with the following members present, to-wit:

Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner Paul Lout, and with all voting "AYE" the Court directed the County Treasurer to transfer 50% of funds received from U. S. Forest Service to County Board of Education for distribution to Schools according to law. The County Treasurer was also directed to prorate the remainder of the funds to the various Commissioner Precincts at 25% to each Precinct after the Treasurer has deducted his commission.

Mr. Johnson met with the Court about Diaster Funds.

Motion by Commissioner Robert E. Smith, seconded by Commissioner Paul Lout the Court adopted the following resolution.
