Motion by Commissioner G. W. Russell, Jr, seconded by Commissioner Paul Lout and

with all voting for the motion, the County Treasurer was directed to transfer the following funds to Officer's Salary Fund:

General County Fund-----	\$19,582.32
Permanent Improvement Fund-----	3,659.56
Jury Fund-----	4,362.92

Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner Paul Lout and with Commissioner G. W. Russell, Jr., Commissioner Paul Lout and Commissioner H. E. Wilburn voting for the motion and Commissioner R. E. Smith voting against the motion, motion carried to distribute Federal Revenue Sharing Funds in the amount of \$23,113.00 as follows:

\$3,000.00 to General County Fund
\$3,000.00 to Officer's Salary Fund for Allowance and Salary of a Deputy Sheriff and a Deputy Pound Master
\$4,278.25-----Road and Bridge No. 1
\$4,278.25-----Road and Bridge No. 2
\$4,278.25-----Road and Bridge No. 3
\$4,278.25-----Road and Bridge No. 4

Motion by Commissioner R. E. Smith, seconded by Commissioner Paul Lout and with all voting "AYE" the Federal Revenue Sharing Funds in the amount of \$4,278.25 designated to Road and Bridge Fund No. 1 in the foregoing motion were transferred into a fund to be used for the renovation and repair of the Sabine County Courthouse.

It was noted by the Court that a pecan tree was planted on the north side of the courthouse lawn by the Hemphill Garden Club on January 18, 1974 at 2:00 P. M.

All accounts were allowed and made payable.

There being no further business, the Court adjourned.
