Re: Statutory Obligations of County Commissioner's Court

I am sure I do not need to enumerate the statutory obligations imposed upon the County Commissioners relative to financial reporting and publication of such reports in a newspaper of general circulation in the County.

It is my understanding that the Sabine County Commissioners Court has never complied with its statutory obligations. That was my understanding as a child and I don't believe the situation has changed.

I have been retained by Phillip Pierce to bring this fact to your attention as County Attorney so that you might bring it to the attention of the Commissioners Court. I have also been authorized to file suits against the Commissioners and the Court if I have not been given reasonable assurance that the Commissioners Court is making a bona fide effort to comply with its obligations.

I have been instructed not to file suits for a period of fourteen days to give you time to respond. Thank you for your attention to this matter.

The County Attorney was directed to reply to the letter including a statement that the Court had already passed a motion to this effect on November 12, 1973, and further, that the Court intended to carry out its obligation of reporting and publication of such reports according to regulations. The First report and publication would be for the first quarter of 1974.

On motion by G. W. Russell, seconded by Paul Lout, the following resolution was adopted pertaining to the County's acceptance and maintenance of the roads in TOLEDO BEACH Subdivision in Sabine County, Texas, to-wit:

That the roads in said subdivision have been constructed for the requisite length of time as required for County Acceptance and Maintenance;

However, the ditches along said roads need to be cleaned out and holes in some of the roads need to be filled and two roads must be reworked, which work would amount to approximately \$2,000.00 in material and labor;

The developer of said subdivision, SID JOHNSON, shall be responsible for doing the above work and to guarantee the performance of said work by SID JOHNSON, he has posted a \$2,000.00 cash bond for the benefit of Sabine County, Texas, which bond shall be forfeited and the proceeds used by the County to do the above work if the said SID JOHNSON has not performed said reworking and repairs to the satisfaction of the Commissioners Court of Sabine County, Texas, within ____180 days from this date. Upon the said Sid Johnson satisfactorily completing said repairs and reworking within said length of time, said cash bond shall be returned to the said SID JOHNSON;

That effective upon the posting of said bond the County of Sabine does hereby accept for maintenance all streets in TOLEDO BEACH Subdivision in Sabine County, Texas.
