Harold Bing, U. S. Department of Labor met in special session with the Court concerning the Fair Labor Standard Act. After explaining the Act to the Court, it was determined that Sabine County was not in compliance with the law which went into effect on May 1, 1974.

In some cases the minimum wage of \$1.90 per hour was not being paid to employees and in some cases time and a half for overtime was not being paid.

The Court assured Mr. Bing that it would take measures necessary to be in complete compliance with the act.

Motion by Commissioner H. E. Wilburn, seconded by Commissioner G. W. Russell, Jr. and by unanimous vote the Court approved the following and directed the clerk to issue the warrants and turn them over to Mr. Bing for such action deemed necessary by the U. S. Dept. of Labor.
