Motion by Commissioner, G. W. Russell, seconded by Commissioner R. E. Smith and by anamious vote the Court adopted the following resolution.

RESOLUTION

Whereas, Babette M. Odom made available to the public a road right of way across her ands providing emergency access to citizens of Sabine ^County, Texas, whose means of ingress and egress over county roads were terminated by the rising waters of Toledo Bend Dam and eservoir project; and,

Whereas, Babette M. Odom made available of the public a road right of way from said emergency road northward across her lands providing access to an area dedicated for public ase; and

Whereas, the State Department of Public ^Highways, through the efforts and encouragement of local governmental agenties and private individuals interested in the development of Sabine county, has established a permanent route to replace much of the emergency access provided by Mrs. Babette M. Odom and has designated such route as a part of the Farm to Market system M 3315, thus assuring adequate design, constructions and maintenance; and,

Whereas, to accommodate the new route as designated by the State Department of Public lighways, it required more of the lands owned by Mrs. Babette M. Odom, who has again provided he public with needed land for road purposes; and,

Whereas, upon completion of the new Farm to Market Road the public will no longer equire the use of that portion of the old lower road previously made available to the County

by Mrs. Babette M. Odom west of its intersection with the access to lands designated for public use to its intersection with FM 3315; and,

Whereas, such unnecessary portion of the old lower road used in the emergency and the land upon which it is located, should be returned to Mrs. Babette M. Odom in the same condition as that which existed prior to the time of such use, insofar as possible; and, Whereas, the Commissioners Court of Sabine, County Texas, wishes to publicly make known and to commit itself to the abandonment and the restoration as above set forth:

Now, Therefore, Be It Resolved By the Commissioners Court of Sabine County, Texas, That: I.

Upon completion of the Farm to Market Road No. 3315, that portion of the old lower county road west of its intersection with the access road to a public use area and east of its intersection with FM 3315, will be abandoned in the manner as provided by the "tatutes.

II.

The resources of the ^County shall be utilized in a cooperative effort with Mrs. Babette M. Odom to restore the abandoned portion of the old lower road and the lands thereby affected to as near as possible that condition which existed prior to the public use thereof, including restoration and/or construction of such improvements, gates, fences, etc. which shall be necessary to accomplish the purposes of this relolution.

III.

The eastern portion of the old lower emergency road, from its intersection with FM 3315 westward to the access road running north to the designated public area, shall remain open and shall be maintained as a county road, or any part thereof, until its abandonment is requested by those landowners upon which the road is located, in accordance with the Statutes.

IV. A copy of this Resolution shall be mailed to Mrs. Babette M. Odom, and such Resolution shall be spread upon the official minutes of this Court, and the County Clerk is so directed.
