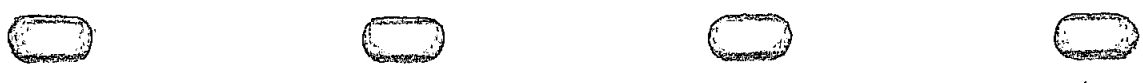
Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner R. W. Smith and by unanimous vote, the above report was approved.
