Motion by G. W. Russell, Commissioner, seconded by Commissioner R. E. Smith and by unanimous vote Judy Oliver was appointed permanent Assistant Deputy Tax Assessor-Collector effective January 1, 1977 at a salary of \$383.71 per month.

Motion by Commissioner Paul Lout, seconded by Commissioner R. E. Smith and with all voting "Aye", Carolyn Garrett was employed for two months as temporary Clerk in the office of Tax Assessor-Collector effective January 1, 1977 at a salary of \$383.71 per month contingent on County finances at the end of the two months.

Motion by Commissioner Paul Lout, seconded by Commissioner G. W. Russell and by unanimous consent, Sylvia Ann Bell would be paid her usual salary in the Mini-bus program until the program gets started again.

Motion by Commissioner Paul Lout, seconded by Commissioner G. W. Russell, Jr. and with all voting "Aye" the Court appointed Connie Waldrop as a permanent employee whose duties would be Deputy County & District Clerk and a clerk in the Treasurer's office when necessary effective January 1, 1977 at a salary of \$383.71.

The Court approved the final contract to provide Child Welfare Service and establish a child welfare board for Sabine County. A Contract to be filed later.

PETITION

to the

COMMISSIONERS COURT OF SABINE COUNTY

We, the undersigned residents and taxpayers of Sabine County, do hereby petition the Commissioners Court of Sabine County to provide a hard surface, black-top roadway from Highway 83 to the subdivisions of Old Sabine Town, Rebel Ridge, River Bend, the Den Marina, Sabine Cove and to other residences on or near Forrest Road 115 which are located in the same general vicinity as the aforementioned subdivisions. We, the petitioners, believe that this hard surface roadway is both desirable and essential to the residents and property owners in this area and to Sabine County in general for the following reasons:

- The area is now accessible only via Forrest Road 115 which is a dirt surface road and which is virtually impassable during periods of inclement weather.
- Many of the residents in this area are senior citizens who must rely on this road for securing the essentials of life and in some cases for communication since phone coverage is not total. In case of emergency, the condition of the existing road could cause a serious delay in obtaining required medical services.
- Construction of a hard surface road in this area would make a significant portion of property on or near Toledo Bend Lake more accessible and hence more attractive to potential investors and residents and would promote and encourage capital investment, thereby increasing the tax base of Sabine County.
- The cost of maintenance would be reduced since grading and ditching of the existing road is frequently required.
- Access to the area for essential services such as mail delivery, *School Bus* phone and electric service and fuel deliveries would be improved.

For all of the above reasons, we solicit the consideration of the Commissioners Court of this petition and encourage their favorable and expeditious approval of the requested roadway.
