I will do all possible to bring about an orderly transition to my successor.

Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner R. E. Smith and by unanimous consent, the following bid to renovate the Hallway of the County Courthouse was accepted by the Court.

TO THE COMMISSIONER'S COURT OF SABINE COUNTY:

I agree to furnish all material necessary to pannel down stairs hall way and stair way landing stop panneling at first door up stairs.

#1 pannel all walls with 1/4" Natural Birch panneling.

#2 pannel base borad.

#3 Install 1-3/4 cove mold at top of panneling.

#4 Install 3/4 round on top of base board for the sum of \$1,.750.00.

THEREFORE, BE IT RESOLVED THAT:

- 1. The County Judge of Sabine County is authorized to enter into agreement for the purpose of forming the Deep East Texas Manpower Consortium.
- 2. The Deep East Texas Manpower Consortium is instructed to seek designation as the Prime Sponsor for operation of CETA Manpower programs in Angelina County and the Deep East Texas Region.
- 3. If the Deep East Texas Manpower Consortium is not designated as the Prime Sponsor, the County will remain as a member of the State of Texas Balance of Texas Prime Sponsor Group.
