Gentlemen:

Mr. J. P. Brackett of 495 Potter Drive, Beaumont, Texas one of my weekend neighbors and a Sabine County Taxpayer has asked me to obtain from you permission for him to employ Southwest Laboratories to make test samples of the County Line Road which was built some years back by the Corps of Engineers.

In May of 1975 Judge Love wrote to Senator John Tower along with others of us and stated that he did not believe that County Line Road was constructed according to the specifications furnished by the Corps of Engineers to Sen. Tower and which he, in turn, forwarded to me.

If this firm can prove what we already know, it might be possible to get some Fedl. funding to bring County Line Road to the condition the Corps of Engineers says it should be in by the specifications.

It is my understanding that Mr. Brackett will have this firm in the area in the next few days and desires permission from the Commissioners Court.
