Upon a motion by Commissioner G.W.Russell, Jr., seconded by Commissioner R. E.Smith and by unanimous consent of the Court the following Resolution was approved:

RESOLUTION

WHEREAS, the County Commissioner's Court of Sabine County being aware of the possibility that assistance might be obtained for development of a Scenic Road in Sabine County through Federal Aid Secondary Funds; and

WHEREAS, the County Commissioner's Court of Sabine County realizing that Federal monies can only be spent on Federal Road Systems; and

WHEREAS, the County Commissioner's Court of Sabine County realizing the importance of improved accessibility to the County's major recreational areas and developments; therefore

BE IT RESOLVED, that the County Commissioner's Court of Sabine County hereby request that F.M. 3382 (FAS Route No. 112) from F.M. 83 South to S.H. 87 be extended from F.M. 83 North to intersection with S.H. 21 and that said extension be placed on the Major Collector System and the Federal Aid Secondary System.
