On this the 23rd day of January, 1978, the Honorable Commissioners' Court met in Regular session with the following present, to-wit:

Motion by Commissioner R. E. Smith, seconded by Commissioner Eldridge Ellison and by unanimous consent the Title II money was transferred to Officers Salary Fund.

John Starr, Jr. appeared before the Court to request assistance in paying Insurance on Ambulance which amount was \$2793.57. Motion by Commissioner Jimmy Vickers, seconded by Commissioner Eldridge Ellison and with all voting "Aye" the court agreed to pay half if the County could legally do so. They also requested a Financial Report of the Ambulance Service be submitted.

Motion by Commissioner G. W. Russell, Jr. seconded by Commissioner Jimmy Vickers with all voting in favor of the motion the Court approved Salary and Expenses of County Agent same as 1977 as follows:

Salary \$242880 Expense (travel) \$499.92 Supplies and Telephone
\$500.00 for the year of 1978.

Forest Service checks in the amount of \$267,672.65 and \$12,153.00 was received. Motion by Commissioner R. E. Smith, seconded by Commissioner G. W. Russell, Jr. and by unanimous consent the court directed the County Treasurer to transfer 50% of the funds received to the County Board of Education for distribution to the Schools according to law and to split the balance as follows:

Precinct No. 1 - 22% Precinct No. 3 - 20%
Precinct No. 2 - 27% Precinct No. 4 - 31%

The Court directed the following amounts be transferred to Officers Salary Fund from Road & Bridge Special:

R. E. Smith-- Salary, Expense, Social Security, Retirement, Fee	\$11,572.12
G. W. Russell, Salary, Expense, Social Security, Retirement, Fee	\$11,572.12
Eldridge Ellison, Salary, Exp. Social Security, Retirement, Fee	\$11,572.12
Jimmy Vickers, Salary, Exp. Social Security, Retirement, Fee	\$11,572.12
W. T. Love - 3/4 Salary, S. S. Retirement, Insurance, Fee	6,964.12
Total	<u>\$53,252.60</u>

Motion by Commissioner G. W. Russell, Jr., seconded by Commissioner, R. E. Smith and with all voting "Aye" the Court directed that each Commissioner not spend in the excess of \$20,000.00 unless otherwise agreed upon by the Court.

Accounts were allowed and made payable.

There being no further business, the Court adjourned.
